**Minimum Eligibility Criteria:**

The bidder whose bid meet the following eligibility criteria would only be considered.

- 1 Legally Valid Entity: The Bidder shall necessarily be a legally valid entity either in the form of Proprietary firm, Partnership firm, Private Limited Company, Limited Company. A proof for supporting the legal validity of the Bidder shall be submitted.
- 2 Financial Capacity: Should have the average annual construction turnover at least **Rs. 50 .00 Lacs** in last three financial years (**2018-19, 2019-20 & 2020-21**). Relevant proof for supporting the above shall be submitted.
- 3 Technical Capability: Should have completed work of similar nature, in the last 7 financial years of the costing not less than the below mentioned value
  - (i) Satisfactory completion of minimum 3 works of Rs 15.30 Lacs each.  
OR
  - (ii) Satisfactory completion of minimum 2 works of Rs 19.10 Lacs each.  
OR
  - (iii) Satisfactory completion of minimum 1 work of Rs 30.60 Lacs .

**Similar Nature Work Means: Interior fit outs, aluminum partition, Gypsum partition, false ceiling, Building Construction.**

ICAT shall accept the attested completion certificates with documentary evidence mentioned at point 3.

In case of submission of completion certificates issued by the private firms, any of the following supporting documents shall be submitted, to establish the genuineness of the completion certificate.

- i. Self-attested copies of TDS certificates issued by the private firm against the payment released on account of the works mentioned in the completion certificate.  
OR
- ii. A Certificate issued by the Chartered Accountant, in support of the payment received from the private firm on account of the works mentioned in the completion certificate.

Only those who meet the eligibility criteria may send their application on their letter head, with complete contact details and Cost of Tender Document, expressing their interest to bid to ICAT to procure the Tender Document from ICAT Office.
