Driver:

Successful bidder shall provider driver and helper for transportation vehicle from

- 1. ICAT, Manesar, HR to NATRAX, Dhar, MP.
- 2. NATRAX, Dhar to ICAT, Manesar, HR.

These two transportation activities will be separated by 6 to 10 days. Except fuel all other cost to be borne by successful bidder.

Driver Documentation:

- 1. Valid driving license for the drivers.
- 2. Driver should have clean driving history (here clean driving record means no violations, at-fault accidents, or traffic-related convictions)

General Terms of Hiring:

- 1. Vehicle will be delivered by vehicle successful bidder at ICAT Centre 2 and after completion of test vehicle will be picked from ICAT Centre 2. Vehicle delivery and pick-up charges should be covered in quotation.
- 2. Vehicle will be submitted at ICAT Centre 2 before 9:00 o'clock in the morning. If delayed then that day will not be counted for vehicle hiring. After completion of project ICAT will inform the supplier for vehicle pick-up either by telephone or written mail. After ICAT confirmation for vehicle pick-up, ICAT will not pay any hiring charges if the supplier does not pick the vehicle on same day.
- 3. Vehicle should be insured and in case of vehicle accident during the test, all the expenses including vehicle transportation from accident location to workshop/service station and repair cost will be borne by successful bidder.
- 4. In case of vehicle accident, ICAT will not bear the hiring charges for the period of vehicle repair. Successful bidder will deliver the vehicle at testing location after vehicle repair. The counting of days will start from next day of vehicle delivery.
- 5. Hiring of vehicles will be tentatively for 25 to 30 days. The number of days may reduce or increase subjective to project completion.
- 6. Successful bidder will provide the vehicle details and if required will display the vehicles to ICAT engineer in a location mutually agreeable before submitting. After ICAT confirmation only vehicle will be submitted. ICAT will not pay as hiring charges for vehicle display.
- 7. After submission of vehicle, the vehicle successful bidder cannot withdrawal the vehicle before completion of project.
- 8. The driver should be well conversant about the routes and must carry the operational mobile phone with him for which, no separate payment shall be made by the ICAT.
- **9.** The agency should abide by all statutory requirements for running the vehicle on contract and ICAT will in no way be liable towards toll charges, taxes, fee, penalties, cost of fuel, and salary to drivers, maintenance or any other charges payable except the contract price.



- 10. The vehicle should have necessary permits from the transport Dept. /Authority. ICAT will not be responsible for any challan, loss, damage and accident to the vehicle or any other vehicle or injury to anybody.
- 11. The contractor should have enough resources to repair their vehicles in minimum possible time. When required, they should be in a position to substitute/replace or arrange extra vehicle at very short notices. In case the vehicle is found not to be in working condition, it shall be returned for immediate replacement. In case no replacement is provided on time, this office would have a right to hire a vehicle from the market and the additional cost incurred by this office will be borne by the contractor.
- 12.Contractor shall comply with all statutory Acts, labour laws/regulations/motor vehicle Act etc.
- 13.All legal obligations which include insurance, pollution control, road tax & other compliances shall be compiled by the contractor & ICAT will not take any responsibility in this regard.
- 14. The vehicle should have the comprehensive insurance of vehicle, driver and passengers etc. to cover the risk during the contract period. In case of any accident, all the claims arising out of it shall be met by the contractor and no claim whatsoever shall be borne by ICAT.
- 15.In case of any dispute of any kind and in any respect whatsoever, the decision of Director ICAT shall be final and binding.
- 16. The contractor shall not engage any sub-contractor or transfer the contract to any other person.
- 17. The contract vehicle will bear proper monograms "On Govt. of India Duty" in Hindi and English at front and rear of the vehicle or any other monogram as approved by ICAT.
- 18. In the scope of services, Driver is required from successful bidder for transporting vehicles from ICAT, Manesar to NATRAX, Dhar, MP and return only. The two activities will be separated by 6 to 10 days. ICAT will not be financially responsible for the driver provided by successful bidder during the sojourn of vehicle at NATRAX, Dhar, MP for testing purpose.

Payment under Contract

- No payment in advance shall be considered.
- Payment for delivery of the services will be made within 15 days subject to finding the service acceptable and in accordance with the instructions given in the contract.
- Counter conditions by the tenderers for matters concerning payment of bills shall not be acceptable.
