Scope of Work Includes:

- As per the gas cylinder rule (Clause. 35) Periodicity of examination and testing of cylinders-No person shall fill any cylinder with compressed gas unless the cylinder has been examined and subjected to hydrostatic test once in a period of 5 years.
- The tenderer shall have hydro testing license and shall be submitted along with the quotation.
- The gas should be non-flammable, nontoxic having zero ozone depletion potential and should be UL Listed.
- The Gas should be filled in UL Listed & PESO approved filling station.
- The cylinders are filled with HFC 227ea (UL Listed) Gas are not supplied to any person who is not holder of a license to possess such cylinder unless he is otherwise exempted under the gas cylinder Rules 2016.
- The tenderer shall visit the site before quoting against Hydro testing of cylinders.

- Gas filling shall be done in presence of concerned person of ICAT and the cost of concerned person fare would be the tenderer.
- Transportation (To & Fro) of 10 nos. of Gas Cylinders will be under scope of tenderer.

Note: It is mandatory for the bidder to comply with the complete technical requirement given in the bid document. In the event the bidder does not comply with the technical requirement, he shall be disqualified and any deviation proposed on technical requirement from the bidder end will not be considered at all. Disqualified bidders will not be eligible to make any claim. Those bidders who meet our technical requirements will be moved forward for financial evaluation. The order would be awarded to the L1 bidder among the technically qualified bidders.
