#### **SCOPE OF SERVICE**

## **General Terms of Hiring:**

1. In total 6 numbers of vehicles are to be transported under this tender in 4 trips. The details of trips are given below;

2. All vehicles are to be picked up, transported to and delivered by successful bidder at addresses tabulated below;

- 3. The vehicles to be sent to NATRAX-Indore, will require a stay-over duration between 3-5 days. Therefore, the bidder shall clearly mention per day stay-over cost for each type of car carrier (1 car carrier / 2 car carrier) at NATRAX-Indore as detailed at Annexure 'B'.
- 4. The estimated value of each vehicle. Further, bidder will facilitate the insurance claim formalities for claiming compensation against damage incurred due to the accident.



- 5. The estimated value of each vehicle is INR 40,00,000/- (Rupees Forty Lakh). Transit insurance of each trip shall be done by the successful bidder to cover all the risk during transit. Premium cost of transit insurance may be included in the final invoice as per actual. In case of any accident during the transit, all the expenses including item transportation from accident location to ICAT-II will be borne by successful bidder. Further, bidder will facilitate the insurance claim formalities for claiming compensation against damage incurred due to the accident.
- 6. The vehicle will be handed over to the successful bidder in operational condition. However, considering these are under test vehicles, these vehicles shall not be driven on road and it shall be transferred in a closed type or concealed car carrier.
- 7. The vehicles are to be transferred in dedicated trucks (single car carrier or double carrier) and not to be shared with third party vehicles. The vehicles to be transported in a closed type or concealed car carrier between two transit points.
- 8. Once the vehicle(s) are loaded in the truck at the pick-up point, the doors will be sealed by ICAT personnel and the seal should be opened in presence of ICAT personnel only at the destination/ delivery point.
- 9. Considering the confidentiality nature of the vehicle, the bidder shall ensure that no photos or videos of the vehicles are taken during the transit. The same also to be conveyed to the staff involved in transportation.
- 10. The vehicles are to be transferred in dedicated trucks (single car carrier or double carrier) and not to be shared with third party vehicles.
- 11. The vehicles shall be transported safely by the bidder without any physical damage to the vehicle. The bidder shall be held responsible for any damage caused during the transit and shall be liable for repair cost of the vehicle for above damage.
- 12. Pick-up and delivery of all the items shall be on official working days during 09:00AM to 05:00PM. The successful bidder shall schedule the pick-up and delivery dates after confirmation from the user department i.e. PSL.
- 13. All items shall be transported from one point to another within 3 days from the date of pick-up. In case of any delay (excluding delays due to natural calamity), then appropriate liquidity damage may be imposed as stated below.
- 14. Liquidity Damages/Penalty for Delay: The successful bidder shall stick to the pick-up and delivery schedule strictly as per time limits provided by PSL. Failure to complete the work within the stipulated time will make the bidder liable to an unconditional penalty of 0.5% (Half Percent) of the value of work per week subjected to a maximum of 10% (Ten Percent) of the work contract.
- 15. The successful bidder shall provide details of the concerned person responsible for shifting as per format provided at Appendix-I. Further, the successful bidder shall provide the details of the transit vehicle and its driver for gate entry and exit formalities at ICAT premises and submit the Bilti with the Tax Invoice.
- 16. The successful bidder shall be responsible for safe loading and unloading of vehicles at pick-up and delivery locations. ICAT will not pay any labor charges for the same.



- 17. Contractor shall comply with all statutory Acts, labour laws/regulations/motor vehicle Act etc for shifting of assets.
- 18. All legal obligations which include insurance, pollution control, road tax & other compliances shall be compiled by the contractor & ICAT will not take any responsibility in this regard.
- 19. In case of any dispute of any kind and in any respect whatsoever, the decision of Director ICAT shall be final and binding.
- 20. The contractor shall not engage any sub-contractor or transfer the contract to any other person.

### **Payment under Contract**

- No payment in advance shall be considered.
- Payment for delivery of the services will be made after successful completion of each trip subject to finding the service acceptable and in accordance with the instructions given in the contract.
- Counter conditions by the tenderers for matters concerning payment of bills shall not be acceptable.
