- This invitation of Tender is for scrap of old batteries lying at ICAT Centre 1 & 2, Manesar Premises
- Details are specified in Annexure B

Terms & Conditions:

- Vendor should be an authorized Distributor/Retailer/Partner of at least one battery Brand.
- The old batteries/lead acid batteries out of old/obsolete/unserviceable ítem tendered for disposal will be stored/process/disposed off as per The Batteries (Management and Handling) Rules, 2001 or as amended from time to time.
- H1 will be declared on total value of scrap in Annexure "B" of Commercial Bid, not with each line item.
- Vendor have to quote for each item mentioned in the scrap list location wise.
- Pick up of batteries will be of vendor's responsibility.
- All ítems should be picked within 15 Days of award of Contract.
- Vendor have to deposit full amount as per contract value before starting pcikup.
- ICAT has right to increase and decrease no. of scrap Battery and Price will be adjusted accordingly.
- Rate of Scrap Batteries (Annexure B) will be applicable for 12 Months for furture Disposal of Batteries if any.
- ICAT will raise Performa Tax Invoice for the same and Tax Invoice with GST will be shared after receipting amount.
- The material will be delivered only to successful bidder or his authorised representatives against the presentation of the buyer's indentity proof. If the successful bidder desires to authorise a representative or an agent to accept delivery, the bidder shall product a suitable power of attorney or authorisation letter for each lot separately, duly attested, by a notary public authorising his representative or agent to lift the material from the seller premises.
- No delivery of the materials wll be given on Saturday, Sunday and closed holiday observed by ICAT. Materials will be delivered between 8:30 AM to 3:30 PM on any working day. The buyer should intimate well in advance as to when vehicle will come for taking out the material.
- No damage shall be caused to the existing property of ICAT or any other Offices in the
 premises while removing the materials from the site. Any loss/damage to the property
 of ICAT Or Other Office in the Premises or Injury or personal accident suffered by any
 person due to negligence or action of the successful bidder or his authorised
 worker/supervisor will be borne by successful bidder and they will be indeminified.
- Goods/Material will be removed under the supervision of designated Officer(s) of ICAT. Material will have to be removed within the time stipulated in acceptance letter.
