#### **1. Eligibility Criteria:**

- Legal Valid Entity: The bidder shall necessarily be a legal valid entity either in the form of Proprietary Firm, Partnership Firm, Private Limited Company. A Proof of legal validity of the Bidder shall be submitted.
- Bidder should have successfully supplied Cabin leakage Tester (same/similar specs w.r.t. our tender), please attach Purchase Order copy.
- If the bidder fails to submit the authenticated documents in support of his/their credentials as specified in tender documents, his/their tender will liable to be rejected summarily.

#### **2. General Terms & Conditions:**

- Sealed bid to be submitted with filling the Attached “Annexure - B” after duly filled and signed on Letter head.
  - Work Location: ICAT Centre - 2, Manesar
  - All Transportation, Accommodation and Fooding Expenses shall be borne by the bidder.
  - Payment Terms: 100% payment after receipt of goods along with original invoice and e-way bill.
  - ICAT reserve the right to reject any or all the tenders in part of full without assigning any reason thereof.
  - The bidder must sign on each and every page of this tender document for it’s acceptability and submit back with the bid document. The bidder must ensure to fill the financial & technical details in Annexure-B &C as per instruction given there under.
  - Liquidity Damages/Penalty for Delay: The work shall be completed strictly as per time limits specified in the work contract/agreement failure to complete the work within the stipulated time will make you liable to an unconditional penalty of ½% (Half Percent) of the value of work per week subjected to a maximum of 10% (Ten Percent) of the work contract.
