1. Eligibility Criteria:

- Bidder should have a minimum experience of 3 years in transport service”
- Bidder should have successfully completed Minimum 3 works of transport service “in last 3 years.
- If the bidder fails to submit the authenticated documents in support of his/their credentials as specified in tender documents, his/their tender will liable to be rejected summarily.
- Tender form is not transferable.

2. General Terms & Conditions:

- a) Sealed bid to be submitted with filling the Attached “Annexure - C” after duly filled and signed on Letter head.
 - b) Payment Terms:
 - No advance payment shall be paid to the Contractor. However, the Contractor shall submit his/her hire bills along with the Trip Sheets duly filled in and signed by the User or Authorized Representative for necessary payment.
 - ICAT shall make payment within 7 days from the date of receipt of bills in order by NEFT/RTGS/Cheque payment.
 - In the event of any dispute on this account, the decision of ICAT shall be final and binding on the Contractor.
 - **Billing:** All Bills and accompanying documents should be raised and submitted in original; as per the Payment Terms, and should be accompanied by original copies of duly receipted/certified Delivery Challan/Work Progress or Completion Certificate, as applicable. No payment shall be released against any duplicate bills, work progress report or Completion Certificate or delivery challan. All applicable taxes such as GST, Service tax, Works Contract Tax shall be mentioned separately in the invoice.
 - c) **Work Location:** ICAT Centre - 1 & NCR Region.
 - d) All Transportation, Accommodation and Fooding Expenses shall be borne by the bidder.
 - e) Payment against submission of Monthly Invoice after satisfactory completion of work.
 - f) ICAT reserve the right to reject any or all the tenders in part of full without assigning any reason thereof. The ICAT also reserves the right to negotiate the rates and terms & conditions with any or all the bidders at its sole discretion as deemed fit without assigning any reasons thereof.
 - g) The comparison of the bids shall be on basis of total price (Inclusive of all taxes etc) quoted by the bidder. No comparison of individual item will be made the individual item charge is only for reference purpose of this office.
3. **Proposal Validity Period:** Bids validity should be of at least **36 Months** from the last date of submission of Bids. Any Bid having validity lower than that specified above shall be rejected by ICAT as being nonresponsive. However, ICAT may request the Bidders to extend the Bid unconditionally beyond the Bid validity period up to an

additional period of **ninety (90) days** without any modification and without giving any reason thereof. Conditional extension of bid validity shall not be accepted and ICAT reserves right to reject such bid/s and proceed with the bidding process with the remaining bidders.

4. **Contract Period: 12 Months** from the date of award of contract. However, the validity of contract period can be extended up to **2 Years** on mutual agreed terms and conditions.
5. **Scope of Work:** transport service for TATA ACE Pickup and Eicher canter 19 Ft. as **per Annexure- B.**

Annexure B

Scope of Work/Services: “Proposal Invited for Transportation Service on ARC Basis for Tata ACE, Pickup and Eicher Canter approx 19 feet for transport of LN2 (Liquid Nitrogen) Container and CNG Cascade for Refilling Purpose on Need and Call Basis at ICAT Centre - 1, Manesar & NCR Region”.

Specification Requirements for Rental of Tata ace, pickup and Eicher canter

Vendors required fulfilling the below mention requirements:

1. Shall be capable to provide the transport service for liquid nitrogen container and cng cascade etc.
2. Normal Route will be between ICAT Centre 1 and LN2 (Liquid Nitrogen) refilling vendor
Route - I From ICAT to M/s. Max Air Pvt Ltd. Sector 8, IMT Manesar.
Route - II From ICAT to M/s. Haryana City Gas, Sector - 86, Gurugram.
Route - III Within 20 KM Range (Up and Down) from ICAT to Supplier Premises.
Note: Approx. Distance between ICAT Centre 1 and Both Stations is 10 KM.
3. The commercial vehicle's should be fit in all respect for operation in accordance with Motor Vehicle Act, Rules and existing laws as applicable from time to time and must be equipped with valid documents, i.e., Registration Book, Insurance Certificate, PUC Certificate, Fitness Certificate, Permit with Taxes, Fees Paid up to date during the Period of Contract.
4. The accessories like wooden plank, metal sheet, ropes, tools etc. required during transportation should be provided by the contractor. After loading arrangement the wheels of the said vehicles should be locked for safe journey. No other consignment is allowed in these vehicles.
5. The contractor shall deploy necessary crew like experienced driver, helper etc. for smooth and safe transportation of the vehicles and they shall make necessary arrangement for offloading the LN2 container and CNG Cascade at ICAT sites.
6. The contractor shall book ACE Pickup & Eicher Canter upon receipt of above requisition and confirm the same immediately and the ACE Pickup & Eicher Canter so booked, shall be made available at the designated place, date and time.
7. In case of said vehicles owned by the contractor are already booked for duties during the time of requisition are made by ICAT, it is obligatory on the part of contractor to arrange if from alternative source on time. Hence, contractor may like to have a tie-up with other Transport agencies.
8. The TATA ACE Pickup and Eicher Canter 19 Ft. shall be requisitioned as and when required by mail, telephonic intimation, fax message or through others means of communication by the officer designated.
9. Payment basis shall be no of trip between ICAT Centre 1 & LN2 (Liquid Nitrogen) and CNG Cascade Refilling stations).
10. For special cases NCR region charges may be as per actual.
11. Commercial vehicles shall be in good condition.
12. Shall have provision for fix the CNG Cascade on the floor of vehicle.
13. Shall be capable of the providing the service within 1 hour of communication done.
14. **Accident/Damagers/Claims/Liabilities**
 - ICAT shall be completely free from any liability whatsoever, in the event of any accident while the Tata ace, pickup and canter engaged under the contract. Contractor will be fully and exclusively responsible for any damages to his vehicle/Property/Death/Bodily Injury to his crew members or any other person in his employment or unauthorized persons travelling in the Tata ace, pickup and

Eicher canter including third party claim. The contractor shall indemnify ICAT against any such claim/compensation.

- Contractor shall also be solely responsible for any consequences under the law, arising out of any accident, equipment or personnel of ICAT caused by his Tata ace; pickup and Eicher canter to the property or personnel of ICAT/third party including death/permanent injury. Contractor shall reimburse on demand compensation/damages, if any, sustained by ICAT/third party on this account.
- The hired vehicle should be fully/comprehensively insured by the Contractor at this own cost for all risk including fire, strike, riots and for commercial use etc. All liability whatsoever arising out of the accident of the hired vehicle shall rest upon the contractor only and ICAT shall fully stand indemnified.
- The Contractor shall be responsible for the acts and/or accidents committed by the person employed by him either inside or outside operational area of ICAT.

Note: It is mandatory for the bidder to comply with the complete technical requirement given in the bid document. In the event the bidder does not comply with the technical requirement, he shall be disqualified and any deviation proposed on technical requirement from the bidder end will not be considered at all. Disqualified bidders will not be eligible to make any claim. Those bidders who meet our technical requirements will be moved forward for financial evaluation. The order would be awarded to the L1 bidder among the technically qualified bidders.
