Annexure-A

Proposal Invited for “Procurement of service for restriction on mobile camera based on location or time of day setting” at ICAT Centre - 1 & 2, Manesar (Haryana)”

1. Eligibility Criteria:

- The Bidder should be a legally valid entity
- Bidder should have a minimum experience of 2 years in above mentioned service”
- Bidder should have successfully completed Minimum 2 installation of blocking of smart mobile cameras “in last 2 years. Must enclosed Two Work orders Copies.

Note: - If the bidder fails to submit the authenticated documents in support of his/their credentials as specified in tender documents, his/their tender will liable to be rejected summarily.

2. General Terms & Conditions:

a) Sealed bid to be submitted along with filled all the Attached Annexure “A”, “B”, “C” & “D” after duly filled and signed on Letter head.

b) Payment Terms:

- ICAT shall make payment after installation of required service and satisfactory completion certificate from user departments.
- In the event of any dispute on this account, the decision of ICAT shall be final and binding on the Contractor.
- Billing: All Bills and accompanying documents should be raised and submitted in original; as per the Payment Terms, and should be accompanied by original copies of duly receipted/certified Delivery Challan/Work Progress or Completion Certificate, as applicable. No payment shall be released against any duplicate bills, work progress report or Completion Certificate or delivery challan. All applicable taxes such as GST, Service tax, Works Contract Tax shall be mentioned separately in the invoice.

c) Work Location: ICAT Centre - 1&2, Manesar.

d) All Transportation, Accommodation and Food Expenses shall be borne by the bidder.

e) ICAT reserve the right to reject any or all the tenders in part of full without assigning any reason thereof. The ICAT also reserves the right to negotiate the rates and terms & conditions with any or all the bidders at its sole discretion as deemed fit without assigning any reasons thereof.

f) The comparison of the bids shall be on basis of total price (Inclusive of all taxes etc) quoted by the bidder. No comparison of individual item will be made the individual item charge is only for reference purpose of this office.

3. **Proposal Validity Period:** Bids validity should be of at least 180 days from the last date of submission of Bids. Any Bid having validity lower than that specified above shall be rejected by ICAT as being nonresponsive. However, ICAT may request the Bidders to extend the Bid unconditionally beyond the Bid validity period up to an additional period of ninety (90) days without any modification and without giving any reason thereof. Conditional extension of bid validity shall not be accepted and ICAT reserves right to reject such bid/s and proceed with the bidding process with the remaining bidders.

4. **Contract Period:** 12 Months from the date of award of work. However, the validity of contact period can be extended on mutual agreed terms and conditions.

Scope of Work/Services:--

Specification Requirements for Smartphone Camera Blocking Requirements

1. Smart phone /Tab/iPad blocked according to time or geographic location (set boundary accuracy will be minimum 5m from ICAT premises in all direction)
2. Camera blocking feature required for Android / iOS.
3. Manually deactivation not possible till the time device is within geographic location
4. Unblocking/deactivation should not be possible through any other application or restart of device
5. Camera blocking app should not access any personal data of smart mobiles / any other device
6. Camera block should work with all upcoming updates of Android / iOS.
7. If person changes his/her device or sim, system should alert the admin.
8. The software should be compliance with national privacy / cyber security law.

Evaluation Parameters

- 1.1 The Bidder who qualifies the minimum eligibility criteria shall only be eligible for Technical Evaluation.
- 1.2 ICAT shall follow segregated bid submission evaluation system. The minimum pass mark in technical bid shall be 14 Points (70%) out of 20 Points. Bidders, who get cut-off marks, will be qualified for next part of evaluation i.e. financial part.

1.3 The Technical Bids shall be awarded points based on the following evaluation criteria: -
