1. Eligibility Criteria:

- Service provider should have minimum 2 years of experience in the field of “Supply of CAN Bus data logger with Telematics and related items”.
- Tender form is not transferable.

2. Technical Conditions:

- **Scope of Services: As per the attached Annexure-B.**

3. General Terms & Conditions:

- Sealed bid to be submitted with Attached Annexure after duly filled and signed on Letter head.
 - Supply Location: ICAT Centre – 1, Manesar
 - All Transportation, Accommodation and Food Expenses shall be borne by the bidder.
 - It is responsibility of bidder to Supply the instrument safely to ICAT without any damage. In case of any damage during transit, damaged instrument will not be accepted.
 - Delivery of the item shall be on official working days during 08:30AM to 04:00PM. The successful bidder shall schedule delivery dates after confirmation from the user department i.e. FTL & Purchase Department.
 - ICAT reserve the right to reject any or all the tenders in part of full without assigning any reason thereof. The ICAT also reserves the right to negotiate the rates and terms & conditions with any or all the bidders at its sole discretion as deemed fit without assigning any reasons thereof.
 - The comparison of the bids shall be on basis of total price (Inclusive of all taxes etc) quoted by the bidder. No comparison of individual item will be made the individual item charge is only for reference purpose of this office.
 - Liquidity Damages/Penalty for Delay: The calibration & certification work shall be completed strictly as per time limits specified in the work contract/agreement failure to complete the work within the stipulated time will make you liable to an unconditional penalty of ½% (Half Percent) of the value of work per week subjected to a maximum of 10% (Ten Percent) of the work contract.
4. Proposal Validity Period: Bids validity should be of at least 6 Months from the last date of submission of Bids. Any Bid having validity lower than that specified above shall be rejected by ICAT as being nonresponsive.
