2. General Terms & Conditions:

- Sealed bid to be submitted with Attached Annexure after duly filled and signed on Letter head.
- Supply Location: ICAT Centre – II, Manesar
- All Transportation, Accommodation and Food Expenses shall be borne by the bidder.
- It is responsibility of bidder to Supply the instrument safely to ICAT without any damage. In case of any damage during transit, damaged instrument will not be accepted.
- Delivery of the item shall be on official working days during 09:00AM to 04:00PM. The successful bidder shall schedule delivery dates after confirmation from the user department i.e. FTL.
- ICAT reserve the right to reject any or all the tenders in part of full without assigning any reason thereof. The ICAT also reserves the right to negotiate the rates and terms & conditions with any or all the bidders at its sole discretion as deemed fit without assigning any reasons thereof.
