- b) Payment Terms:
 - ICAT shall make payment after submission of invoice.
 - In the event of any dispute on this account, the decision of ICAT shall be final and binding on the Contractor.
- c) Work Location: ICAT Centre 2, Manesar.
- d) ICAT reserve the right to reject any or all the tenders in part of full without assigning any reason thereof.
- e) The comparison of the bids shall be on basis of total price (Inclusive of all taxes etc) quoted by the bidder. No comparison of individual item will be made the individual item charge is only for reference purpose of this office.
