 - 100% Payment against Invoice.
 - In the event of any dispute on this account, the decision of ICAT shall be final and binding on the Contractor.
- c) Work Location: ICAT Centre 1, Manesar.
- d) ICAT reserve the right to reject any or all the tenders in part of full without assigning any reason thereof.
- e) The comparison of the bids shall be on basis of total price (Inclusive of all taxes etc) quoted by the bidder. No comparison of individual item will be made the individual item charge is only for reference purpose of this office.
- 3. **Proposal Validity Period:** Bids validity should be of at least 45 daysfrom the last date of submission of Bids. Any Bid having validity lower than that specified above shall be rejected by ICAT as being nonresponsive. However, ICAT may request the Bidders to extend the Bid unconditionally beyond the Bid validity period up to an additional period of ninety (45) days without any modification and without giving any reason thereof.
