Exemption & Preference	<p><b>MSME Exemption Applicability:</b> If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.</p> <p style="text-align: center;"><b>And</b></p> <p><b>Preference to Make In India products (For bids &lt; 200 Crore):</b> Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than INR 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate. In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.</p>

Legally Valid Entity:</b></p> <p>The Bidder shall necessarily be a legally valid entity either in the form of Proprietary firm, Partnership firm, Private Limited Company. A proof for supporting the legal validity of the Bidder shall be submitted.</p> <p><b>B. Financial Capacity:</b></p> <p>The bidder should have the average annual turnover of atleast <b>INR 50 Lakhs</b> In last <b>3</b> financial years (2020-21 &amp; 2021-22 &amp; 2022-23). Relevant proof for supporting the above shall be submitted.</p> <p><b>C. Technical Capability:</b></p> <ul style="list-style-type: none"> <li>• The Bidder shall be a Company which is in design, fabricated and executing <b>Aluminum (material grade AL 6082-T6)</b> automotive testing fixtures with <b>mimum 3 Years of experience in the relevant business.</b></li> <li>• Experience of having successfully completed <b>2</b> project in field dsign and fabrication of Aluminum Automotive Test Fixtures (i.e., Instrumentation Panel and Floor Console) during last <b>5 Financial Years</b> ending last day of month previous to the in which bids are invited.</li> <li>• The bidder should have presence in India with their technical support team for “after sale service support”. The bidder should have technical manpower with experience to provide service in Delhi/NCR region.</li> <li>• A proof for supporting above points shall be submitted by the bidder.</li> </ul> <p><b>D. Supporting Documents for Minimum Eligibility Criteria:</b></p> <ul style="list-style-type: none"> <li>• In proof of having fully adhered to the minimum eligibility criteria at 3 (A), attested copy of certificates issued by the respective registrar of firms/companies and in case of proprietary frims, valid documents such as PAN, TAN, GST Registration etc. shall be acceptable to ICAT. In proof having fully adhered to the minimum eligibility criteria at 3 (B), attested copies of the audited balance sheet or any such valid documents, prepared and duly signed by chartered accountant, clearly indicating the turnover of the bidder acceptable to ICAT.</li> <li>• In proof of having fully adhered to the minimum eligibility criteria at 3 (C), ICAT shall accept the attested completion certificates or Purchase/Work Orders issued by Govt.
