• Eligibility Criteria:

- Bidder should have a minimum experience of 3 years in Passenger Elevator Repairing or AMC related similar nature of work.
- Eperience of having successfully completed at least 2 similar Elevator AMC work during last 3 years from the date inviting this tender in Central/Stage Government/PSU/Reputed Private Institutions. Document proof in support of the above shall be produced along with bid, failure to which the offer may be disqualified.
- Bidder should be comply with the complete Eligibility Criteria and technical requirement given in the Annexure A "Eligibility Criteria" & Anneuxre B " Scope of Work/Services".
- The bidder must have a valid PAN No. & GST Document.
- The bidder or any of its members should not be blacklisted or prosecuted by any authority in India.
- If the bidder fails to submit the authenticated documents in support of his/their credentials as specified in tender documents, his/their tender will liable to be rejected summarily.
- Tender form is not transferable.
- It is mandatory for the bidder to comply with the complete eligibility criterial given in "Annexure A" & Scope of Services given in the bid document "Annexure B". In the event the bidder does not comply with the above, he shall be disqualified and any deviation proposed on technical specification from the bidder end will not be considered at all. - **2. AMC Period:** The AMC contract initially for a period of 12 Months (1 Year) from the date of issuance of contract and can be extended for further on mutual consent on the same rates, terms and conditions. The contractor shall continue the service on same terms until a new contractor is in place. The contract is extendable for a further period of 1 Year on same terms and conditions at the discretion of the ICAT.
- **3. Payment Terms:** No advance payment will be made. Payment will be made Half Yearly Basis against submission of Invoice by Electronic Mode Directly in Bidders A/c. Taxes, if any, will be deducted from Bill/Tax Invoice at the prevailing rates.
- **4.** ICAT reserves the right to accept/reject any or all of the quotation without assigning any reason thereof. Unrealistic prices quoted by the bidder would debar them from being considered for this and future contracts by this office. Applications are liable to be summarily rejected due to incomplete information/incorrect information/non fulfillment of basic criteria. ICAT decision in this shall be final.
- **5.** The comparison of the bids shall be on basis of total price (Inclusive of all taxes etc) quoted by the bidder. No comparison of individual item will be made the individual item charge is only for reference purpose of this office.
- **6. Proposal Validity Period:** Bids validity should be of at least **12 Months** from the last date of submission of Bids. Any Bid having validity lower than that specified above shall be rejected by ICAT as being nonresponsive. However, ICAT may request the Bidders to extend the Bid unconditionally beyond the Bid validity period up to an additional period of **ninety (90) days** without any modification and without giving any reason thereof. Conditional extension of bid validity shall not be accepted and ICAT reserves right to reject such bid/s and proceed with the bidding process with the remaining bidders.



- 7. At any time, prior to the date of submission of the tender, the department may for any reasons, modify/ amend bid document.
- 8. The department, may at its discretion, extend the deadline for submission of tender.
- **9**. **Termination of Contract:** ICAT reserves the right to terminate the contract at any time without assigning any reason by giving one month's notice to the contractor.
- **10**. In case of any dispute the decision of the Director, ICAT shall be final and binding upon both the parties.
- 11. Conditional bids are liable to be summarily rejected.
- **12.** The work in full or part shall not be subletted to other agency. If such a violation comes to the notice of the ICAT, ICAT shall be free to terminate the contract with immediate effect.
- 13. The contractor shall be responsible for behavior and conduct of it's workers. Worker with doubtful integrity or having a bad record shall not be engaged by the contractor. In this regard, it is also to be stated that the antecedents of the mechanics/ labourers to be deployed by the firm for execution of AMC work, may be verified from the local police.
- 14. ICAT reserves the right to reject or accept any or all the tenders without assigning any reason.
- 15. All litigation will be subject to the court of Jurisdiction at Gurugram (Haryana).

16. Force Majeure:

- Should any force majeure circumstances arise, each of the contracting parties be excused for the non-fulfilment or for the delayed fulfilment of any of its Contractual obligations, if the affected party within 15 days of its occurrence informs in a written form to the other party.
- Force Majeure shall means fires, flood, natural disaster or other acts such as war, turmoil, sabotage, explosions, epidemics, quarantine restriction, strikes, lock-outs etc. beyond the control of either party.

Scope of Service/Work :-

- Breakdown Maintenance, which includes fault detection, repair, and functional checking.
- There should be 12 preventive maintenance visits during the contract period.
- The service provider must attend an unlimited number of breakdown calls.
- The breakdown response time should not exceed 4 hours.
- Spare parts should be arranged within 4 hours after the cause of breakdown is detected.
- Safety Certificate to be provided.
- The department will be at the liberty to ask for source and proof of procurement of materials used to repair/replacement of the machine.
- Systematically examine and adjust the following components: Machine, Worm Gear, Thrust Bearing, Drive Sheave, Drive Sheave Bearing, Break Contact, Lining and components, etc.
- Maintenance of Wire Rope and Chain (where fitted) as often as required to maintain an adequate factor of safety to equalize the tension on hoisting rope
- The firm may visit the office for look at systems before submit the quotation in working days/ hours with pre-intimation and permission of competent authority of the Office.
- Any accident or damage during maintenance/ operation will be the responsibility of the contractor and the ICAT will not entertain any claim, compensation, penalty etc; on this account or on account of non observation of any other requirement of law relevant to his work. The contractor will ensure all precautionary measures and safety arrangements while executing the work and will be responsible for any accident occurred during duty hours.
- The Service engineers of the vendor shall make unlimited visits on Call basis in case of emergency breakdown. Breakdown maintenance shall have to be undertaken whenever required.
- All Tools & Tackles required for Maintenance work shall have to be provided by the bidder at no extra cost.
- Bidder will test all safety devices in accordance with the relevant safety standards at no extra cost as per company norms except full load testing which shall be at extra cost.
- **Response Time:** If breakdown call or any type of complaint is given before 03:00 PM on any working Day, it shall be attended on the same day. If call is given after 03:00 PM, it will be attended by 12.00 Noon on the next working day.
