2. <u>ICAT General Terms & Conditions</u>:

- Completion Period: 120 Days from the date of Issuance PO.
- **Contractor Warranty/Guarantee Period:** 6 Month's warranty/guarantee against poor/substandard quality of work.
- Liquidity Damages/Penalty for Delay: The delivery of the item shall be completed strictly as per time limits specified in the work contract/agreement, failure to complete the delivery within the stipulated time will make you liable to an unconditional penalty of ½% (Half Percent) of the value of work per week subjected to a maximum of 10% (Ten Percent) of the work contract.
