Any damage caused to the equipment / gadget / instrument will attract a penalty of free of cost replacement of same Make/Type.
- **Payment Terms: 100% payment after completion of Work and submission of Final Invoice.**

No payment shall be released against any duplicate bills, work progress report or Completion Certificate or delivery challan. All applicable taxes such as GST, Service tax, Works Contract Tax shall be mentioned separately in the invoice.**

- All other statutory deductions applicable such as GST & TDS (if any applicable) will be deducted at source.
- **Quotation Criteria:** The bidder whose bid meets the technical specification given above would only be considered (As per conditions mentioned in Evaluation Criteria).
