Scope of Services

The scope and nature of the services to be provided by the contractor shall include scheduled preventive maintenance services which cover calibrations, periodic and breakdown servicing.

Annual Maintenance Services (Scope of Work):

- 2 Preventive Maintenance Services (On a half yearly basis).
- 2 Calibration Service (Once in every 6 months)
- Minimum of 2 Breakdown Calls (Whenever required).
- Attending breakdown call within 24 Hrs.
- First Preventive maintenance service visit to be made within one month of PO generation/issue or payment.
- Under the Annual Maintenance Service Contract, the contractor shall maintain the Weatherometer under AMC as indicated in “Annexure – A” in good working condition throughout the period of contract.
- Any defect in the electrical installation, water and compressed air supply will be attended to and rectified by ICAT.
- ICAT has the right to cancel the contract within 30 days of written notice and will be liable to one twelfth of the contract charges of each month till the contract is in effect.
- The scope of work shall include all checks and tests as detailed under routine maintenance services. In addition, annual maintenance services (preventive maintenance) shall also include checks related to:
- **For Test Chamber:** Rack Rotation, Slip ring, Spray Nozzles, Light sensor, BPT/BST Sensor, Humidity / Temp. sensor.
- **For Xenon Lamp:** Xenon burner, Inner & Outer filter, Seal - outer filter, Lamp leads & clamp, Ignition unit & its connection.
- **For Electronics:** LA IO Board, Touch Panel, PLC, and CPU.
- Air filter, Flow switch, DM Cartridge, Cooling coil, Solenoid Valves DI Water, Solenoid valve Lamp cooling, Chamber Blower motor and Lenze Drive, Damper Motor, Boost Voltage, Igniter, interference filters, Motor and pump assembly, Safety switches.
