- **Delivery /Completion Period: 90 Days from the date of Issuance PO.**
- **Liquidity Damages/Penalty for Delay:** The delivery and Installation and Commissioning of the item, Installation and Commissioning shall be completed strictly as per time limits specified in the work contract/agreement, failure to complete the delivery within the stipulated time will make you liable to an unconditional penalty of ½% (Half Percent) of the value of work per week subjected to a maximum of 10% (Ten Percent) of the work contract.
- **Payment Term:** 60% Payment after delivery & 40% after Installation and Commissioning.
