- **Scope of Supply: Supply of Network Attached Storage at ICAT Centre - 1, Manesar, Haryana.**
- **Delivery Period:60 Days from the date of Issuance PO.**
- **Liquidity Damages/Penalty for Delay:** The delivery of the item shall be completed strictly as per time limits specified in the work contract/agreement, failure to complete the delivery within the stipulated time will make you liable to an unconditional penalty of ½% (Half Percent) of the value of work per week subjected to a maximum of 10% (Ten Percent) of the work contract.
