> The new battery supplied shall fit into the existing battery rack, else vendor shall provide suitable battery rack along with battery set within the rate quoted. Any deviation from the specified battery dimensions will only be acceptable under the following conditions. The bidder will be disqualified if they do not agree to any of the options given below:

Option I: If the bidder agrees to install batteries in the existing battery bank racks, including the required accessories such as terminal and connectors, at their own expense. ICAT will not cover any expenses for fitting the batteries in the existing battery bank.

Or

Option II: If the bidder's proposed battery dimensions do not fit in the existing battery bank rack, the bidder will be responsible for providing new battery bank rack according to their proposed dimensions, along with all necessary accessories for fitting the batteries, at no cost. ICAT will not cover any costs for the new battery bank rack and accessories.



- ➤ The offered battery should be manufactured in India.
- ➤ Battery should not be more than 6 Months old at the time of supply.
- > The batteries quoted are note "end-of-life or end-of-sale products" as of the bid submission date. If the support for the product quoted has been stopped or withdrawn until the time of delivery of Batteries, the same will be changed with the superior product at no extra cost.
- > The new battery supplied shall fit into the existing battery rack, else vendor shall provide suitable battery rack along with battery set within the rate quoted.
- ➤ Buy Back: The bidder should have a valid license to buy back old batteries or have authorization from OEM's. The bidder will be entirely responsible for the safe disposal of old batteries without affecting the environment in any manner as per prevailing statutory rules and Act/Law of the Land.
- ➤ The Battery set shall be installed in the existing battery rack at ICAT Centre 1, Manesar. The work includes transportation of Battery Set at ICAT Installation Site, release of Old Battery Set, Installation of New Battery Set, buy back of old released battery set. The supplier shall provide the required battery interconnecting cable and fixing material for the installation of the Battery Set.
- > The successful bidder must remove the old goods from the ICAT premises at the time of the supply, installation, and commissioning of fresh batteries. The seller will be entitled to payment only after the removal of old batteries from ICAT premises and after successful supply, installation, testing and commissioning of new batteries in terms of the contract.
- > The bidder shall provide a comprehensive onsite warranty of 2 Years (12 Months) for the new batteries. The period of comprehensive on-site warranty will start from the date of installation of items but not later than 30 days from the date of supply of items in the ICAT. The bidders shall furnish and undertake from the OEM of the concerned product that they shall supply spares for the quoted product for one year after the warranty period is over.
- ➤ The bidder should quote the products strictly as per the tender specifications. Complete technical details, along with the brand, specification, technical literature, etc., highlighting the specifications, must be supplied along with the technical bid. A Statement of Compliance shall be given against each item in the prescribed format given in the Technical Specification. The compliance statements should be supported by authentic documents. Each page of the bid and cutting/corrections shall be duly signed and stamped by the authorised signatory. Failure to comply with this requirement may result in the bid being rejected.
- ➤ **Delivery, Installation, and Commissioning:** The delivery of items, testing, and installation, in all respects, must be completed along with the delivery of warranty documents within **90** days from the receipt of the purchase order.


