- **Delivery/Completion Period:** Within 60 days from the date of issuance NTP (Notice to Proceed)
- Warranty Period: 3 Month's from the date of completion the overhauling of the unit at ICAT Site. Free of cost to rectify the issue if noted any problem due to overhauling of the unit only.
- Liquidity Damages: The overhauling of the item shall be completed strictly as per time limits specified in the work contract/agreement, failure to complete the delivery within the stipulated time will make you liable to an unconditional penalty of ½% (Half Percent) of the value of work per week subjected to a maximum of 10% (Ten Percent) of the work contract.
