All applicable taxes such as GST, service tax, and works contract tax shall be mentioned separately in the invoice.
- **Proposal Validity Period:** Bids validity should be of at least 90 days from the last date of submission of Bids. Any Bid having validity lower than that specified above shall be rejected by ICAT as being nonresponsive.
