ICAT Introduction: The International Centre for Automotive Technology (ICAT) was established in 2006 in Manesar, Haryana, India. ICAT is located approximately 38 KM from Delhi Airport and operates two centres with areas measuring 08 acres and 46 acres, respectively.

How to Apply: Eligible suppliers must submit their applications in the prescribed format, as detailed in **Annexure "C"** attached herewith, along with all supporting documents, in a sealed envelope to:

Important Notice: Application for registration with ICAT does not confer any right or assurance whatsoever to the applicant that they will be registered on the panel of ICAT. A letter confirming the registration will be issued by ICAT separately to the successful suppliers.

Guidelines for Registration of Suppliers: These guidelines are designed to provide and regulate the manner and procedure for the registration of suppliers for fabrication and delivery of fixtures as per drawings at ICAT. These guidelines supersede any existing instructions on this matter, if any, and are subject to change without prior notice.

Eligibility for Registration: Before submitting the application, suppliers are advised to carefully review and comply with the eligibility criteria, instructions, and terms and conditions for registration at ICAT outlined herein.

Qualification & Experience (Eligibility Criteria):

A. Legally Valid Entity: The bidder must be a legally recognized entity, either as a Proprietary Firm, Partnership Firm, Private Limited Company, or Limited Company. Proof of the legal validity of the bidder must be submitted.

- B. Financial Capacity:** The bidder must have an average annual turnover of at least INR 10 Lakhs in the last three financial years (2021-22, 2022-23, and 2023-24). Relevant supporting documents must be submitted.
- C. Technical Capability:** The bidder must have completed a minimum of six fabrication projects in the last three financial years. Relevant supporting documents must be submitted.
- D. Proximity to ICAT Centre:** The bidder's premises must be located within 50 KM of ICAT Centre 1, Plot 26, Sector 3, IMT Manesar.
- E. Self-Declaration:** A self-declaration that the firm is not blacklisted by the Government of India or any government bodies due to involvement in corrupt, fraudulent, collusive, or coercive practices, or for any failure/lapses of a serious nature.

Documents Required to be Submitted by the Supplier: Suppliers must submit their applications in the prescribed format (Annexure-B), along with self-attested copies of the following documents, duly signed by an authorized representative of the firm:

1. **Proof of Legal Entity (Point A):** Attested copy of registration certificates issued by the respective registrar of firms/companies, or for proprietary firms, valid documents such as PAN, TAN, GST, etc.
2. **Proof of Financial Capacity (Point B):** Attested copies of audited balance sheets or equivalent documents signed by a Chartered Accountant, clearly indicating the turnover of the bidder.
3. **Proof of Technical Capability (Point C):** ICAT will accept purchase orders from customers as proof.
4. **Proximity to ICAT (Point D):** Google map screenshot showing the distance from ICAT Centre 1.
5. **Self-Declaration (Point E):** Self-declaration certificate on the company's letterhead regarding the requirements as per Point D above.

Tenure of Registration: The initial registration will be for a period of three (3) years. ICAT reserves the right to terminate the registration of any supplier at any time, without assigning any reason.

Procedure for Registration: The Competent Authority of ICAT will consider applications for registration in accordance with these guidelines, based on merit. The Competent Authority may authorize any officer(s) to appraise the applications, who will assess compliance with the minimum eligibility criteria.

Registration Process:

- a) **The application must be submitted using the prescribed format only. Applications in any other format will not be entertained.**
- b) **Applications received after the last prescribed date will not be considered.**
- c) **No applicant will be called for interaction unless they satisfy the eligibility criteria and are shortlisted.**

- d) Based on the requirements and the number of applications received, ICAT reserves the right to shortlist suppliers for registration.
 - e) Meeting the eligibility criteria does not automatically confer the right to registration.
 - f) The decision of ICAT's Competent Authority regarding shortlisting and selection of suppliers shall be final.
 - g) Canvassing or lobbying in any form will lead to disqualification and immediate removal from the process.
 - h) The applicant must present the original documents during the interaction with ICAT.

Scope of Work:

- a) ICAT will communicate requirements to registered suppliers via email.
 - b) Drawings for fixtures will be shared via email.
 - c) The scope includes the fabrication of fixtures as per the provided drawings and delivery of these fixtures to ICAT.

Removal from Registered Panel:

1. ICAT reserves the right to terminate the registration of any supplier with one month's notice in writing, without assigning any reason. The supplier may also resign from the registration by serving one month's notice.
 2. Registration may be cancelled in the following circumstances:
 - 2.1 Violation of ICAT's discipline policy.
 - 2.2 Untimely delivery of fixtures.
 - 2.3 Fixtures not conforming to the provided drawings.
 - 2.4 Failure to submit quotations on time.

General Instructions:

- a) The size of the registered panel and the number of suppliers in the panel will be determined by ICAT's Competent Authority based on the requirements and quantum of work.
 - b) Refusal by any supplier to accept work without reasonable cause (e.g., conflict of interest) may result in removal from the panel.
 - c) Suppliers must accept the terms and conditions of registration as determined by ICAT, which may change from time to time.

Tender Conditions for Empanelment

1. **Empanelment Duration:** The empanelment of the selected suppliers/fabricators shall be valid for a period of thirty-six (36) months from the date of issue of the empanelment letter, subject to the supplier's continued compliance with the terms and conditions set forth in this Tender.
2. **Performance Monitoring:** The supplier's performance will be continuously monitored

during the empanelment period based on quality of services, adherence to delivery timelines, and compliance with specifications. Any failure to meet the required standards may lead to de-empanelment or termination of the agreement.

3. **Quality of Services:** The supplier/fabricator shall ensure the highest quality of services, including the manufacture, fabrication, and delivery of fixtures in accordance with the technical specifications and requirements stipulated by ICAT. The quality shall be subject to periodic inspection and testing and must meet the approved standards.
4. **Timely Delivery:** The supplier/fabricator is required to strictly adhere to the delivery timelines as specified in the purchase orders issued by ICAT. Any delays in delivery without valid reasons may result in penalties or removal from the empanelled list.
5. **Compliance with Terms and Conditions:** The supplier/fabricator shall comply with all the terms and conditions outlined in this tender document. Non-compliance may result in the termination of the empanelment, and the supplier may be disqualified from future tenders.
6. **Renewal and Termination:** The empanelment may be extended for further periods based on the satisfactory performance of the supplier/fabricator, as determined by ICAT. ICAT reserves the right to terminate the empanelment at any time during the 36-month period if the supplier/fabricator fails to meet quality standards, delivery timelines, or other terms and conditions.
7. **Confidentiality:** The supplier/fabricator agrees to maintain confidentiality of all information related to ICAT, the tender process, and the services provided during the empanelment period.
8. **Force Majeure:** In the event of any unforeseeable circumstances such as natural disasters, strikes, or other force majeure events, the supplier/fabricator shall promptly notify ICAT. Any extension or waiver of deadlines shall be at the sole discretion of ICAT based on the situation.
9. **Dispute Resolution:** In case of any dispute or difference arising out of the interpretation or execution of the terms of this tender, the matter shall be referred to arbitration as per the prevailing arbitration laws in India.
10. **Liability and Indemnity:** The supplier/fabricator shall be responsible for any loss, damage, or injury arising out of their negligence, defective goods, or failure to meet the agreed standards. The supplier/fabricator shall indemnify ICAT against any claims or liabilities arising from such events.
11. **Liquidated Damages (LD) Clause:**
 - **Liquidated Damages for Delay in Delivery:** In the event that the fabricator fails to deliver the fixtures within the agreed timelines as specified in the purchase orders or delivery schedule, liquidated damages shall be imposed. The fabricator shall be liable to pay a penalty of 0.5% of the total order value for each calendar week of delay, subject to a maximum limit up to 10% of the total order value.
 - **Commencement of LD:** The calculation of liquidated damages shall commence from the expiry of the agreed delivery date until the actual date of delivery. Delays caused by reasons not attributable to the fabricator, such as force majeure events, shall not be considered for the imposition of liquidated damages, provided the fabricator informs ICAT in writing within 7 days of the occurrence of such an event.

- **Application of Liquidated Damages:** Liquidated damages will be deducted from any payments due to the fabricator. If the fabricator fails to make the required delivery after the imposition of liquidated damages, ICAT reserves the right to terminate the empanelment or cancel the order and seek alternative suppliers/fabricators at the fabricator's risk and cost.
- **Mitigation of Delay:** The fabricator is encouraged to take all reasonable steps to mitigate any delay and avoid imposition of liquidated damages. In case of anticipated delays, the fabricator must notify ICAT promptly with a revised delivery schedule and request for any extension, subject to approval by ICAT.
- **No Limitation of Rights:** The imposition of liquidated damages shall not limit ICAT's rights or remedies available under the contract or law, including the right to claim damages for any actual loss suffered by ICAT due to delays or other defaults by the fabricator.

12. Non-Confirmation of Guaranteed Business Clause

- **No Guarantee of Business:** The empanelment of a fabricator/supplier does not constitute a guarantee or assurance of any business or procurement orders from ICAT. The inclusion of the fabricator/supplier in the empanelled list is for the purpose of being considered for future tenders or orders, subject to specific requirements, evaluation, and discretion of ICAT.
- **Order Placement:** ICAT reserves the right to issue orders or procure goods/services from any of the empanelled fabricators/suppliers based on its actual requirements, preferences, and the terms of specific tenders. The empanelled fabricator/supplier is not entitled to any minimum volume or value of orders.
- **No Obligation for ICAT:** ICAT shall not be bound to place any purchase orders with the empanelled fabricator/supplier during the empanelment period. The decision to place orders, if any, shall be based on the needs of ICAT and the suitability of the fabricator/supplier at the time of procurement.
- **No Right to Claim Business:** The empanelled fabricator/supplier shall not have any claim for business or expect any guarantees for the placement of orders during the empanelment period. Any orders issued shall be at the sole discretion of ICAT.
- **No Financial Commitment:** The empanelment does not create any financial commitment or obligation on ICAT to procure any services or products from the empanelled fabricator/supplier, nor does it assure any level of business over the empanelment period.

13. Termination Clause:

- **Termination for Convenience:** ICAT reserves the right to terminate the empanelment of the fabricator/supplier at any time, without assigning any reason, by providing thirty (30) days' prior written notice. In such cases, ICAT will not be liable for any claims, losses, or damages arising from the termination of the empanelment.
- **Termination for Default:** ICAT may terminate the empanelment with immediate effect if the fabricator/supplier:
 - Fails to comply with the terms and conditions of the empanelment, including but not

limited to quality standards, delivery timelines, or contractual obligations.

- Is found to be involved in fraudulent, corrupt, or unethical practices.
 - Provides false or misleading information during the empanelment or tender process.
 - Fails to maintain required licenses, registrations, or legal standing as per applicable laws.
 - Is unable to perform or deliver goods/services as per the agreed specifications or requirements or demonstrates consistent non-performance.
 - Is blacklisted or debarred by any government authority or regulatory body during the empanelment period.
- **Termination for Insolvency or Bankruptcy:** ICAT may terminate the empanelment if the fabricator/supplier becomes insolvent, files for bankruptcy, or is otherwise unable to meet its financial obligations.
- **Termination Due to Force Majeure:** If the fabricator/supplier is unable to fulfil its obligations due to an event of force majeure (such as natural disasters, war, strikes, etc.), either party may terminate the empanelment by providing written notice, without penalty, subject to evidence of the force majeure event. The fabricator/supplier must promptly inform ICAT of such an event and its anticipated impact on the performance of the contract.
- **Consequences of Termination:** Upon termination of the empanelment, the following shall apply:
- Any outstanding dues or payments for services/products already rendered by the fabricator/supplier up to the date of termination will be settled as per the terms of the contract.
 - ICAT may seek alternative suppliers/fabricators for the services/products, and any additional costs incurred due to the fabricator's failure to perform will be borne by the fabricator/supplier.
 - ICAT reserves the right to debar the fabricator/supplier from future tenders or empanelment's for a specified period, in case of termination due to default or unethical conduct.

"A bidder shall not have conflict of interest with other bidders for particular quoted item. Such conflict of interest can lead to anti-competitive practices to the detriment of Procuring Entity's

interests. The bidder found to have a conflict of interest shall be disqualified. A bidder may be considered to have a conflict of interest with one or more parties in this bidding process for particular quoted item, if:

- a) *they have proprietor/ partner(s)/ Director(s) in common; or*
- b) *they receive or have received any direct or indirect subsidy/ financial stake from any of them; or*
- c) *they have the same legal representative/ agent for purposes of this bid; or*
- d) *they have relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another bidder; or*
- e) *bidder participates in more than one bid in this bidding process. Participation by a bidder in more than one Bid will result in the disqualification of all bids in which the parties are involved. However, this does not limit the inclusion of the components/ sub-assembly/ assemblies from one bidding manufacturer in more than one bid.*
- f) *in cases of agents quoting in offshore procurements, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry.
