**Scope of Work: Supply of General-Purpose Low Noise Accelerometer Cable in EEL at Centre-I, Manesar (Haryana)**

- **Delivery Period:60 Days from the date of Issuance PO.**
  - **Liquidity Damages/Penalty for Delay:** The delivery of the item shall be completed strictly as per time limits specified in the work contract/agreement, failure to complete the delivery within the stipulated time will make you liable to an unconditional penalty of ½% (Half Percent) of the value of work per week subjected to a maximum of 10% (Ten Percent) of the work contract.
  - **Payment Term:** 100% Payment after delivery of defect free defect material and submission of Invoice along with valid e-way bill at ICAT Site.
