Minimum Technical Specification Required: -

300 MBPS 1:1 Fiber lease line with Managed services along with the following technical solution required.

Technical Requirements for 300 Mbps 1:1 Fiber Lease Line with Managed Services:

1. **End-to-End Managed Service:** The solution must include complete router management services as part of the end-to-end fiber connectivity, ensuring uninterrupted service and comprehensive management across the entire network.
2. **Static IP Addresses:** A minimum of 8 static IP addresses must be provided as part of the service to facilitate seamless network configuration and operation.
3. **Cybersecurity and Protection Features:** The solution must incorporate a full range of cybersecurity features to safeguard the network, including but not limited to control of Shadow IT, detection and prevention of malicious activities, protection against vulnerabilities, and defences against hacking attempts.
4. **Incident Management and Reporting:** In the event of any malicious activities, vulnerabilities, or security breaches, immediate remedial actions must be undertaken. A detailed incident report outlining the actions taken must be submitted to ICAT. If necessary, the ICAT public IP must be replaced immediately to mitigate any ongoing risk.
5. **24/7 Technical Support:** The vendor shall provide round-the-clock technical support (24x7) for the entire duration of the contract, ensuring prompt response and resolution to any service-related issues.
6. **Vendor-Supplier Scope:** The vendor is responsible for supplying and installing all required hardware within the ICAT premises, ensuring full functionality and performance as per the agreed specifications.
7. **Power Supply:** ICAT will provide the UPS (Uninterruptible Power Supply) power required to support the leased line and associated equipment.

Maintenance

3. **Fault Resolution Efforts:** Upon receipt of a fault report, the Supplier shall make reasonable efforts to restore normal operation of the services as soon as reasonably practicable.
