1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
  1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
  2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
  3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.
8. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. In case Primary products of only one OEM are left in contention for participation in RA based on lowest 50% bidders qualifying for RA, the number of sellers qualifying for RA would be increased to get at least products of one more OEM (directly participated or through its reseller) if available. Further, if bid(s) of any seller(s) eligible for MSE preference is / are coming within price band of 15% of Non MSE L-1 or if bid of any seller(s) eligible for Make in India preference is / are coming within price band of 20% of non MII L-1, then such MSE / Make in India seller shall also be allowed to participate in the RA process.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

### Minimum Eligibility, Bid Evaluation & Disqualification Criteria

This Invitation for bid is open to all bidders having minimum **3 (three)** years of experience in the field of **“Calibration of different type of instruments within the various defined NABL Calibration disciplines”**.

#### Pre-qualification/Minimum Eligibility Criteria for the Bidders:

- 1. Legal Valid Entity:** The bidder shall necessarily be a legal valid entity in the form of a proprietary firm, partnership firm, private limited company, or agency (enclose a copy of the registration or incorporation certificate with the technical bid).

**In support of above, the bidder is required to submit the following documents with the technical bid:**

- **Proprietary Firm:** A copy of the registration certificate or any relevant document that proves the establishment and legal validity of the proprietary firm.
- **Partnership Firm:** A copy of the Partnership Deed along with the registration certificate issued by the Registrar of Firms, if applicable.
- **Private Limited Company:** A copy of the Certificate of Incorporation issued by the Registrar of Companies (RoC) along with the Memorandum of Association (MOA) and Articles of Association (AOA).
- **Agency:** A copy of the registration certificate or any official document proving the legal validity and registration of the agency under the applicable law (e.g., registration under the Shops and Establishments Act, or other relevant legislation).

**These documents should be enclosed along with the technical bid to demonstrate the legal status of the bidder as a valid entity.**

- 2. Calibration Lab (Bidder) should be ISO/IEC 17025:2017 Accredited (Latest Valid Certificate to be provided along with technical bid).**
- 3. Bidders are required to submit complete proposals covering all instruments specified in the bid document. Any proposal that is incomplete, including but not limited to failure to provide a bid for any instrument or part thereof, will be deemed non-compliant with the requirements of the calibration tender. In such cases, the incomplete proposal will be rejected and automatically disqualified from further evaluation. Bidders must ensure their proposals include valid offers for all items listed in the tender documents. Failure to comply with this condition will result in the outright rejection of the bid.**
- 4. The bidder must be a firm or company with an in-house capability to perform calibration for at least 75% of the instruments listed in the tender. The bidder may outsource the calibration of up to a maximum of 25% of the instruments specified in the bid document to an associated entity holding ISO/IEC 17025:2017 accreditation. The latest valid certificate and the scope of accreditation for the outsourcing lab must be provided along with the technical bid.**
- 5. CMC (Calibration Measurement Capability) should be provided along with the bid.**
- 6. Turnover:** The bidders should have an average annual turnover of INR **0.25 Cr.** in the last three consecutive financial years (FY 2021-22, 2022-23, and 2023-24). The tenderers shall submit Certificates to this effect which may be an attested certificate from the concerned department/client or Audited Balance Sheet duly certified by the Chartered Accountant/Certificate from Chartered Accountant duly supported by Audited Balance Sheet. The contact details of CA/Statutory Auditor along with UDIN No. shall be mandatorily mentioned on copy of certified Balance Sheet/Certificate.
- 7. The bidder must have successfully completed at least 3 Calibration Projects within the last three (3) years, in line with the instruments specified in the bid document. These projects may involve clients such as, but not limited to, Central Government, State Government, Public Sector Undertakings (PSUs), Autonomous Bodies, OEMs, or private firms in India.**



8. **References:** The Bidder must provide performance and reference certificates from representatives of recent projects, **as required under point no. 8 above**. ICAT may contact these representatives to obtain feedback and assess the quality of the services provided.
9. Bidders should not have been blacklisted by any departments or ministries of the government of India or of any state government, PSU, or any reputable private firm or institution in India. A declaration must be submitted to this effect with the tender document.

- ICAT reserves the right to give preference to the local supplier, MSME, or start-up as per prevailing government notifications and as revised from time to time.
- MSE Public Procurement Policy is meant for the procurement of only goods produced and services rendered by MSEs. However, traders, distributors, sole agents, and works contracts are excluded from the purview of the Public Procurement Policy for MSEs Order, 2012.
- It is clarified that the relaxation of prior **turnover and prior experience** with respect to micro and small enterprises is subject to meeting the quality and technical specifications given in the bid document.

**Bid Rejection Criteria:**

### Tender Terms & Conditions

1. **Scope of Work/Services:** Annual Rate Contract for the Calibration of General-Purpose Instruments (Mechanical, Thermal, Pressure, and ET Parameters) at ICAT Centre - 1 & 2, Manesar (Haryana) for a duration of 2 years (24 months). **For complete scope of work, please refer Annexure - X of the bid document.**
2. Bidders are invited to submit their proposals for the "**Annual Rate Contract for Calibration of General-Purpose Instruments (Mechanical, Thermal, Pressure & ET Parameters) at ICAT Centre - 1 & 2, Manesar, Gurugram - 122051 (Haryana)**" under the two-bid system through the GeM portal. Proposals must comply with the conditions outlined in the bid document, as well as the terms defined by the GeM portal. It is important to note that financial or commercial documents should not be included with the technical bid. Any bidder who submits financial proposals along with the technical bid will be immediately disqualified, and no further claims or representations will be entertained.
3. **Site Visit:**
  - 3.1 Bidders are strongly advised to visit and assess the working conditions of the instruments and their surrounding areas, with prior notice to ICAT, at their own cost. It is the responsibility of the bidder to gather all necessary information required for the preparation of the tender. By submitting the tender, the bidder will be deemed to have inspected the site and its surroundings, and to have considered all relevant factors pertaining to the site. Bidders must coordinate with the designated ICAT representative to schedule the site visit.

4. **Time Schedule for Completion of Works:** The expected completion timeline will be provided by the user department (Calibration Lab) based on the instruments scheduled for calibration. The selected agency must complete the entire calibration activity within the timeline specified by the user department (Calibration Lab).
5. **Contract Period:** The Annual Rate Contract (ARC) will be valid for a period of 24 months from the date of the award of the contract on the GeM Portal. However, ICAT will issue internal orders to the L1 bidder on an annual basis and may extend the contract for an additional year, subject to mutually agreed terms and conditions, based on the quality of services provided by the L1 bidder on GeM. ICAT reserves the right to terminate the contract at any time if the services provided by the GeM bidder do not meet the terms and conditions outlined in the contract.
6. **Liquidity Damages:** Time is of the essence in this contract. In the event the Contractor/Bidder fails to deliver the services or complete the work within the stipulated time frame as specified in the Purchase/Work Order, the Contractor shall be liable to pay liquidated damages at the rate of 0.5% (half of one percent) of the contract value per week, or part thereof, of delay, subject to a maximum of 10% (ten percent) of the total contract value. The Bidders shall not have any cause of action or claim against ICAT for rejection of their bids.

**13. Notification of Award by Issuance of "Letter of Acceptance/Purchase Order":**

- Prior to the expiry of the period of Bid validity prescribed, ICAT will issue to the Successful Bidder, the "Letter of Acceptance/Purchase Order (PO)" in duplicate. The Successful Bidder shall return one copy of the Letter of Acceptance to ICAT duly acknowledged and signed by the authorized signatory, within



- seven [15] days of receipt of the same by him.
- The Letter of Acceptance/PO shall constitute a part of the Contract.
  - No correspondence will be entertained by ICAT from the unsuccessful Bidders.
14. **Inspection and Quality Control (Prior to Finalization of Contract):** Inspection and Quality Control (Prior to Finalization of Contract): ICAT or its nominated representative reserves the right to inspect and assess the quality of the services to ensure compliance with the contract specifications and other quality control requirements outlined in the tender.
15. **Process to be Confidential:**
- Except the public opening of Bids, information relating to the examination, clarification, evaluation and comparison of Bids and recommendations concerning the award of Contract should not be disclosed to Bidders or other persons not officially concerned with such process.
  - Any effort by a Bidder to influence ICAT or any of its functionaries in the process of examination, clarification, evaluation, and comparison of tenders and in decisions concerning award of contract, may result in the rejection of the Bid.
  - As part of his Technical Bid, the Bidder should be required to furnish an undertaking for confidentiality.
16. **Deviation from Tender Clauses:** Bidders are required to submit their tender in strict compliance with the terms, conditions, and specifications outlined in the Tender Documents, without proposing any deviations. Conditional bids are liable to be rejected.
17. **Acceptance/Rejection of Tender:**
- ICAT is not obligated to accept the lowest tender.
  - ICAT reserves the right to accept or reject any tender, in part or in full, without providing any reasons.
  - ICAT also reserves the absolute right to reject any or all tenders at any stage, including based on the bidder's past unsatisfactory performance. The decision or opinion of ICAT in this regard shall be final and binding.
18. **Corrections:** No corrections or overwriting will be accepted in the schedule of rates using correction fluid. Any corrections made in the schedule of rates must be initialed by the bidder.
19. **Abnormal Rates:** The tenderer is required to quote rates for each item after thoroughly analyzing the costs involved in performing the complete task, considering the technical requirements and contract conditions. This will help prevent any loss or gain due to changes or curtailment of specifications for any item. If the unit rates quoted by the tenderer for any items are found to be unusually high or low, it may result in the rejection of the tender, unless ICAT is satisfied with the reasonableness of the quoted rates. The tenderer may be asked to provide a detailed analysis of such unit rates upon request. Notwithstanding any other provisions, once the rates are accepted by ICAT, they shall be final and non-negotiable, and no changes will be allowed, whether due to unworkability of the unit rates or for any other reason.
20. **Firm Rates:** The rates quoted by the bidder shall remain firm and unchanged until the completion of all work, including any extended period, regardless of the circumstances. No deviations in this regard will be accepted and offers that do not contain firm prices will not be considered.
21. **Language of Bid:** The bid submitted by the bidder, along with all correspondence and documents related to the bid exchanged between the bidder and the authority, must be in English.   - Once the contract is terminated, any amounts deemed payable to the contractor (if applicable) will be withheld, and no further payments will be made. No additional claims from the contractor will be entertained. The contractor must withdraw their services from ICAT within one month of the contract termination.
  - The decision of the competent authority of ICAT regarding performance assessment will be final and binding.
27. **Confidential Information:** Both ICAT and the Selected Bidder agree to maintain the confidentiality of all documents, data, and other information disclosed by either party (the "Disclosing Party") to the other (the "Receiving Party") in connection with the Contract. Neither party shall, without the prior written consent of the other party, disclose such information to any third party. This obligation of confidentiality shall apply to information provided before, during, and after the execution, completion, or termination of the Contract.
28. **Any Dispute/Difference arising out of or relating to this tender:** Matter regarding any dispute shall be referred for arbitration to any office appointed by the Director of ICAT, whose decision shall be binding and final. Even after arbitration if any questions, disputes and/or difference arise under and out of, or in connection with the work, if concluded, shall be referred to the High Court of Haryana or any other court in the District of Gurugram (Haryana).



29. **Law of the Republic of India are applicable to this tender.**

32. **Force Majeure:** Force Majeure is herein defined as any cause, which is beyond control of the selected Bidder or the ICAT as the case may be which they could not foresee, or this a reasonable amount of diligence could not have foreseen, and which substantially affect the performance of the Contract, such as: Natural phenomena, including but not limited to floods, droughts, earthquakes, epidemics; Acts of any Government, including but not limited to war, declared or undeclared, priorities, quarantines, embargoes; Terrorist attacks, public unrest in work are Restriction, Freight Embargo; provided either party shall within ten (10) days from the occurrence of such a cause notify the other in writing of such causes. The Bidder or the ICAT shall not be liable for delay in performing his/her obligations resulting from any Force Majeure cause as referred to and/or defined above.
33. **Subcontracting:** The bidder may outsource the calibration of up to a maximum of 25% of the instruments specified in the bid document to an associated entity holding ISO/IEC 17025:2017 accreditation. The latest valid certificate and the scope of accreditation for the outsourcing lab must be provided along with the technical bid.
34. **MSME Exemption Applicability:** If the bidder is a Micro or Small Enterprise as per the latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. ICAT reserves the right to give preference to the local supplier, MSME, or start-up as per prevailing government notifications and as revised from time to time.
- MSE Public Procurement Policy is meant for the procurement of only goods produced and services rendered by MSEs. However, traders, distributors, sole agents, and works contracts are excluded from the purview of the Public Procurement Policy for MSEs Order, 2012.

Such conflict of interest can lead to anti-competitive practices to the detriment of Procuring Entity's interests. The bidder found to have a conflict of interest shall be disqualified. A bidder may be considered to have a conflict of interest with one or more parties in this bidding process for particular quoted item, if:

- a) *they have proprietor/ partner(s)/ Director(s) in common; or*
- b) *they receive or have received any direct or indirect subsidy/ financial stake from any of them; or*
- c) *they have the same legal representative/ agent for purposes of this bid; or*
- d) *they have relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another bidder; or*
- e) *bidder participates in more than one bid in this bidding process. Participation by a bidder in more than one Bid will result in the disqualification of all bids in which the parties are involved. However, this does not limit the inclusion of the components/ sub-assembly/ assemblies from one bidding manufacturer in more than one bid.*
- f) *in cases of agents quoting in offshore procurements, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry. One manufacturer can also authorize only one agent/ dealer. There can be only one bid from the following:*
  1. *The principal manufacturer directly or through one Indian agent on his behalf; and*
  2. *Indian/ foreign agent on behalf of only one principal.*
- g) *a Bidder or any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the contract that is the subject of the Bid;*
- h) *In case of a holding company having more than one independently manufacturing units or more than one unit having common business ownership / management, only one unit should quote. Similar restrictions would apply to closely related sister companies. Bidders must proactively declare such sister/ common business/ management units in same/ similar line of business.*
- i) *Bidder shall not act in contravention/ violation to the provisions of competition act, as amended from time to time".*
