1. Minimum Eligibility Criteria:

- Any bid failing to meet the eligibility criteria below shall be summarily rejected and will not be considered for Financial Evaluation:
- The bidder shall necessarily be a legal valid entity in the form of Proprietary Firm, Partnership Firm, Private Limited Company/ agency (enclose a copy of registration / incorporation certificate with technical bid).
 - Note: These documents should be enclosed along with the technical bid to demonstrate the legal status of the bidder as a valid entity.
- Bidder must have PAN & GST (enclose a copy of PAN & GST with technical bid)
- The bidder should submit the bid document duly stamped & signed all the pages. If the bidder fails to submit attested tender document, his/their tender will be liable to be rejected summarily.
- It is a mandatory requirement for bidders to submit comprehensive proposals covering all items specified in the bid document. Any bidder who submits an incomplete proposal, including but not limited to failure to provide a bid for any item or part thereof, shall be considered non-compliant with the tender specifications. Such incomplete proposals shall be rejected and automatically disqualified from further evaluation. Bidders are required to ensure that their proposal includes valid offers for all items as detailed in the tender documents. Non-compliance with this condition shall result in the outright rejection of the bid.
- Bidder should have executed at least 3 similar type of work order i.e. supply, testing, and commissioning of air receiver tanks of similar capacity and specifications. (supporting document required).
- The bidder must provide detailed technical specifications of the air receiver tank, including material test certificates for Mild Steel (MOC), wall thickness, and proof of compliance with IS or equivalent standards.
- The bidder should either be the manufacturer of the air receiver tank or an authorized dealer/distributor with a valid authorization certificate.
- The bidder should have an operational office or service center within Delhi NCR.
- The air receiver tank must conform to IS 2825 or equivalent standards for unfired pressure vessels.
- The bidder must submit technical drawings and layouts for approval.
- Tender form is not transferable

2. <u>Instructions for submission of the tender</u>:

• Firms interested in quoting the rates and undertaking the work may kindly visit ICAT on any working day at least a week prior to the last date of bid submission (timing for visit 8.30 AM to 3.30 PM), except Saturday, Sunday & Holidays. The Bidders are advised to visit the site to acquaint themselves as to the nature and location of the work, access to the site, the general & local conditions, disposal and handling of materials,



availability of labor, physical conditions etc. and should be included on such account while quoting for the tender.

3. Amendment to NIT (Notice Inviting Tender):

• At any time prior to the deadline for submission of bids, ICAT or its authorized representative may, for any reason, whether at its own initiative or otherwise or in response to any clarification requested by a prospective Bidder, modify the NIT by amendment. The amendment will be notified in writing to all prospective Bidders who have received the NIT, and the amendment will be binding on them. In order to afford prospective Bidders reasonable time to take the amendment into account in preparing their tenders, extension of time as may be reasonable, will be given for submission of tenders

4. Submission of Tender:

• The Bidder shall bear all costs associated with the preparation and submission of Bid and ICAT will not be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

5. General Terms & Conditions:

- Online bid to be submitted on e-procurement portal under 2 bid system with filling complete all the Attached "Annexures" after duly filled and signed on Letter head.
- All Transportation, Accommodation and Food Expenses shall be borne by the bidder.
- The comparison of the bids shall be on basis of total price (Inclusive of all taxes etc.) quoted by the bidder. No comparison of individual items will be made, the individual item charge is only for reference purposes of this office.
- Liquidity Damages (LD): The work/service should be completed strictly as per time limits specified in the work contract/agreement, failure to complete the work/service within the stipulated time will make you liable to an unconditional penalty of ½% (Half Percent) of the value of work per week subjected to a maximum of 10% (Ten Percent) of the work contract/purchase order.
- The engagement and employment of workers, Driver, Supervisors and payment of wages to them as per existing provisions of Statutory labor compliance, various labor laws and regulations is the sole responsibility of the contractor and any breach of such laws or regulations shall be deemed to be breach of this contract.
- During the supply, transportation, loading & unloading & during the execution of work if any loss is incurred that will be borne by the supplier and the supplier will not claim any loss or mishappening expenditure.

6. Proposal Validity Period:

Bids validity should be at least 180 days from the last date of submission of Bids. Any Bid having validity lower than that specified above shall be rejected by ICAT as being nonresponsive. However, ICAT may request the Bidders to extend the Bid unconditionally beyond the Bid validity period up to an additional period of **thirty (30) days** without any modification and without giving any reason thereof. Conditional extension of bid validity shall not be accepted and ICAT reserves the right to reject such bid/s and proceed with the bidding process with the remaining bidders.



7. Other Conditions:

- i. Any theft or damage during transportation shall be the responsibility of the contractor and the replacement shall be done by the contractor, at its own cost.
- ii. The selected Contractor shall be held responsible for all or any of the act done by the staff
 /Workers and shall be alone responsible for the payment of wages or any loss or damage caused by them during the course of delivery or work undertaken and shall also be responsible and be liable for payment of any compensation under workmen compensation Act. The ICAT will not be liable for any such event whatsoever.
- iii. No advance payment will be made by ICAT for any reason whatsoever.
- iv. All the documents submitted should be duly signed & stamped by the bidders.
- v. ICAT reserves the right to reject any or all the tenders at any stage in part or full without assigning any reason thereof.
- vi. The Driver of the vehicle used for the supply of the material shall have all the valid papers for the vehicle, such as RC, PUC, valid insurance and Driving license etc. The vehicle will not be allowed inside the ICAT premises, in case Driver not have all the proper valid documents mentioned above.
