- Scope of Supply: The scope of supply includes the delivery of overhauling spare parts
 required for the maintenance and servicing of HORIBA MEXA analyzers installed in the
 Emission Testing Laboratory (ETL) at ICAT Centre 1, Manesar, Haryana. All spare parts
 shall be genuine, new, and conform to the specifications prescribed by the Original
 Equipment Manufacturer (OEM), intended to ensure the continued functionality, accuracy,
 and reliability of the equipment.
- **2. Delivery and Completion Period:** The bidder shall deliver the overhauling spare parts for HORIBA MEXA within a maximum period of **300** *Calendar Days* from the date of issuance of the Purchase Order. Time is of the essence, and adherence to this timeline is mandatory to ensure successful project execution. Any delay in delivery **shall attract penalties as per Clause 3 below.**
- 3. **Liquidated Damages for Delay:** In the event of delay in delivery, Liquidated Damages (LD) shall be levied at **0.5%** of the value of undelivered items per week (or part thereof), subject to a maximum of **10%** of the total order value. LD shall be calculated only on the delayed portion of the delivery and will be deducted from the payment due. This is without prejudice to ICAT's right to terminate the contract or seek other legal remedies for non-performance.
- 4. **Partial Deliveries:** Partial deliveries will be accepted only with prior written approval from ICAT. Each partial delivery must conform to all documentation and quality standards. Payment for such deliveries shall be made only after inspection and acceptance by ICAT. Approval of partial delivery shall not waive the supplier's obligation to complete full delivery as per contract. LD will apply on any portion delayed beyond the approved timeline.
- 5. **Warranty Clause for Spares:** The supplier shall provide a warranty for all spare parts supplied under this contract, in accordance with the Original Equipment Manufacturers (OEM's)



standard warranty terms. During the warranty period, any spare part found to be defective due to **faulty design**, **material**, **or workmanship** shall be repaired or replaced **free of cost** by the supplier. This includes all associated costs such as **transportation**, **labor**, **and logistics**, if applicable. The supplier shall ensure that all spares are **new**, **genuine**, **and sourced directly from the OEM or its authorized distributor**, and carry the **full OEM warranty**, as applicable. The supplier shall facilitate the warranty claim process on behalf of the purchaser, in coordination with the OEM, if required.

- 6. **Payment Terms:** Payment will be made within fifteen (15) days from the date of receipt defect-free material at ICAT Site.
- 7. **Price Validity:** The quoted prices must remain valid for a minimum period of 180 days from the last date of bid submission. No escalation in rates shall be permitted during the validity or contract period, and no subsidy or additional charges will be entertained over and above the quoted prices.
- 8. **Price Ceiling:** The quoted prices shall not exceed the applicable controlled prices, if any, fixed by the Central or State Government, and in no case shall the quoted price exceed the Maximum Retail Price (MRP) of the items.
- 9. **Delivery Terms:** All deliveries must be made on a FOR (Free on Road) basis to ICAT, Manesar. Prices must include all packing, loading, forwarding, transit insurance, unloading, and other incidental charges necessary for safe delivery.
- 10. **Insurance and Risk Responsibility:** The supplier shall ensure that all goods are fully insured during transit and shall bear full responsibility for any loss, damage, or defects until final delivery and acceptance by ICAT. In case of loss or damage, the supplier must replace the items at no additional cost to ICAT. ICAT reserves the right to reject any consignment, in whole or in part, not meeting specifications at any stage of inspection.
- 11. **Quantity Variation Clause:** The quantities mentioned in the tender are indicative and subject to variation. ICAT reserves the right to increase or decrease the quantity of any item as per its operational requirements during the contract period.
- 12. **Rate Escalation:** No escalation in rates will be entertained on any ground during the entire contract period. Any such request will lead to disqualification or termination of the contract. Additionally, no financial assistance, subsidy, or compensation shall be provided beyond the quoted rates.
- 13. **Packing Instructions:** Supplier should supply the materials with proper packing and making for transit so as to be received at the destination without any loss or damage of the materials.
- 14. **Supply In Original Packing:** The items (wherever applicable) shall be supplied in original packing from the manufacturer clearly indicating quality no., name of company, manufacturing date. The supply shall be completed as prescribed in the Purchase Order.

- **3.
