1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be

exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.

- 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. - 7. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
 - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
 - v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

- Bidders must note that price bid should not be disclosed in the technical bid, else their bid may not be considered and will stand rejected.
- Bidders are requested to quote their price with breakup of AMC cost towards each equipment individually as per format given in the Price bid only.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Annual Maintenance Services (Scope of Work/SLA):

- Non-Comprehensive AMC of M/s Sierra CP Equipments installed at ETL at ICAT Centre-1, Gurugram (Haryana) for a period of 01 Year
- Ensure that the equipment up time should not go below 92% within the year, this will be calculated & detailed summary sheet will be shared to ICAT at the end of every 6 months.
- Depute a skilled local engineer to provide onsite service support.
- Root cause identification must conclude within 48 hours of issue reporting. However, time for rectification of the breakdown may vary depending on the availability of required spares (for which costing to be borne by ICAT) or any genuine reason.
- It shall be the responsibility of the service provider to make the equipment work satisfactorily throughout the contract period, also to hand over the equipment to the department in working condition on expiry of the contract.
- Carry out minimum 4 no's Preventive Maintenance visits and Unlimited breakdown visits per year. Breakdown must be attended within 24 hours from the receipt of formal email request of the breakdown.
- Following points must be considered during Preventive Maintenance, apart from bidders standard check points:
 - ➤ Check unit operation thoroughly including Electrical cables, Components in the Electrical and Control panels, Safety Devices, Sensors etc.
 - > Check the Motor and panel cooling fans for clearances and free operation.
 - > Check the tightness of panel fan motor mounting brackets and set screws on all equipment's.
 - > Cleaning of electrical panels and verify the performance of the dyno control inverter VFD, if applicable.
 - ➤ Verify the operation of the Dynamometer bearing and Greasing of bearings as required.
 - > Verify the working condition of all indicator/ alarm lights and LED/LCD displays.
 - > Test oil pressure safety device (as required). Calibrate and record setting.
 - > Test the operation of the CAHU, FMS, Dynamo meter, VFD starter auxiliary contacts, if applicable.
 - ➤ Inspect wiring and connections for tightness and signs of overheating and discoloration
 - ➤ Check contactors for free and smooth operation and condition of contacts for wear and pitting.

- ➤ Verify the operation of the electrical interlocks and measure voltage and record: Voltage should be nominal voltage ±10%.

Minimum Eligibility Criteria:

Eligibility Criteria: The following mentions the pre-qualification criteria. A bidder participating in the procurement process shall possess the following pre-qualification/minimum eligibility criteria: Any bid failing to meet the stated criteria shall be summarily rejected and will not be considered for technical evaluation.

Pre-qualification/Minimum Eligibility Criteria for the Bidders:

1. **Legal Valid Entity:** The bidder shall necessarily be a legal valid entity in the form of a proprietary firm, partnership firm, private limited company, or agency (enclose a copy of the registration or incorporation certificate with the technical bid).

In support of above, the bidder is required to submit the following documents with the technical bid:

- **Proprietary Firm:** A copy of the registration certificate or any relevant document that proves the establishment and legal validity of the proprietary firm.
- **Partnership Firm:** A copy of the Partnership Deed along with the registration certificate issued by the Registrar of Firms, if applicable.
- ➤ **Private Limited Company:** A copy of the Certificate of Incorporation issued by the Registrar of Companies (RoC) along with the Memorandum of Association (MOA) and Articles of Association (AOA).
- Agency: A copy of the registration certificate or any official document proving the legal validity and registration of the agency under the applicable law (e.g., registration under the Shops and Establishments Act, or other relevant legislation).
- 2. Bidders are required to submit the duly stamped & signed copy of this complete ATC towards the acceptance to fulfil the complete technical specification & compliance of this ATC.
- 3. It is a mandatory requirement for bidders to submit comprehensive proposals covering all items specified in the bid document. Any bidder who submits an incomplete proposal, including but not limited to failure to provide a bid for any item or part thereof, shall be considered non-compliant with the tender specifications. Such incomplete proposals shall be rejected and automatically disqualified from further evaluation.
