- The bidder is required to ensure that the product proposed in response to this tender should fully comply with the technical specifications outlined in **“Annexure A”**. The proposed solution must meet or exceed the specified performance standards. The bidder must provide comprehensive documentation to demonstrate that the proposed product fully meets these requirements. If the product proposed by the bidder fails to meet the specified technical criteria, it will be considered non-compliant and will result in the disqualification of the bidder from further consideration in this tender process.
- The bidder should quote the products strictly as per the tender specifications. Complete technical details, along with the brand, specification, technical literature, etc., highlighting the specifications, must be supplied along with the technical bid. A Statement of Compliance shall be given against each item in the prescribed format given in the Technical Specification. The compliance statements should be supported by authentic documents. Each page of the bid and cutting/corrections shall be duly signed and stamped by the authorized signatory. Failure to comply with this requirement may result in the bid being rejected

Minimum Eligibility Criteria:

Any bid failing to meet the eligibility criteria below shall be summarily rejected and will not be considered for Financial Evaluation:

1. The bidder shall necessarily be a legal valid entity in the form of Proprietary Firm, Partnership Firm, Private Limited Company/ agency (enclose a copy of registration / incorporation certificate with technical bid).
2. Bidder must have PAN & GST (enclose a copy of PAN & GST with technical bid)
3. The bidder should meet the technical specifications as mentioned in Annexure A.
4. Bidder should have a minimum experience of 2 years in Motor Winding related related Similar nature of work.
5. Bidder should submit the bid document i.e. (ATC) duly stamped & signed all the pages. If the bidder fails to submit attested tender document, his/their tender will be liable to be rejected summarily.
6. Along with the bidding documents, please submit a product catalogue (as applicable) for evaluation purposes. The acceptance means that you agree to provide the products as per our specifications.
7. Tender form is not transferable
8. The bidder should comply with the complete technical requirements as mentioned in ATC.

Annexure C

General Terms & Conditions

1. The bidder is required to sign each page of each part of this tender document (ATC) for acceptance of terms and conditions and submit along with the bid.
2. ICAT reserves the right to reject any or all the tenders in part in full without assigning any reason thereof.
3. It is mandatory for the bidder to comply with the complete technical requirement given in the bid document. In the event the bidder does not comply with the technical requirement, he shall be disqualified, and any deviation proposed on technical requirement from the bidder end will not be considered at all. Disqualified bidders will not be eligible to make any claim. Those bidders who meet our technical requirements will be moved forward for financial evaluation. The order would be awarded to the L1 bidder among the technically qualified bidders.
4. **Bid Validity/Price Validity: 180** days from the bid end date.
5. **Billing:** All bills and accompanying documents should be raised and submitted in original, as per the payment terms and should be accompanied by original copies of duly receipted/certified delivery challan/work progress or completion certificate, as applicable. No payment shall be released against any duplicate bills, work progress report or completion certificate or delivery challan. All applicable taxes such as GST, service tax, works contract tax shall be mentioned separately in the invoice.
6. **Payment Terms:** 100% Payment after Satisfactory Service work and Submission of Invoice.
7. **Warranty:** 6 Month on F Class Insulation
8. **ARC Period: 1 Year** from the date of Contract.
9. **Liquidity Damages/Penalty for Delay:** Liquidated Damages: If the Seller/Service Provider/Supply fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, 0.5% of the contract value of delayed quantity per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.
10. It is the responsibility of the bidder to supply the material safely to ICAT without any damage. In case of any damage during transit damaged material will not be accepted.
11. Applicable statutory taxes will be deducted at source.
