- 1. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the eligibility criteria of "Experier Criteria" as defined above subject to their meeting of quality and technical specifications. - 2. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications.
