If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experier Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking exemp from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications.
