Special Instructions and Conditions:

The contractor must follow the instructions before starting the work and during the work:

- All materials required for the project as per NIT will be in scope of the bidder. The bidder shall
 ensure that all materials required for the work to be supplied shall be new and free from all defects
 and faults, Prior approval will be taken from ICAT Representative before supplying or use the
 material.
- All aspects of safe delivery shall be the exclusive responsibility of the bidder. ICAT will have the
 right to reject the material supplied if they do not comply with the specification at any point of use
 or inspection. If any material or part thereof is lost or rendered defective during transit, the supplier
 shall immediately arrange for the supply of material or part thereof, as the case may be, at no extra
 cost.
- All tools and consumable items to complete the work will be in scope of bidder.
- All safety measures will be taken by the contractor during work and all safety equipment such as: safety helmet, safety shoes, safety belt, safety goggles etc. (as applicable) will be in scope of contractor and must be used during the work.
- It is the responsibility of the bidder to keep the material safe at ICAT site.
- It is the responsibility of the bidder to keep the site safe and clean as much as possible.
- After the completion of the project, the site should be neat and cleaned before handover.
- The contractor must follow the procedure for material approval and work permission.
- While working at site, some restrictions may be imposed by Site In-Charge/Security Staff of ICAT
 or Local Authorities regarding Safety and Security etc. The contractor shall be bound to follow all
 such restrictions/instructions & nothing extra shall be payable on this account.

- No labour hutment shall be allowed in premises. All labourers should leave the site after day's work. The security & Watch Ward of site contractor materials/work etc. shall be at his cost only.
- All rates quoted by the bidders shall remain firm for the contract period/extended contract period.
- If the contractor fails to proceed with the work within the stipulated time as specified from the date
 of issue of letter of intent/letter to proceed with the work, the ICAT reserves the right to cancel the
