Important Notes:

- ➤ Variable Quantities: There shall be no fixed quantity of Strain gauges and accessories to be supplied during the term of this Contract. The quantities mentioned above in Annexure B is tentative only. The Purchaser's requirements shall vary based on operational needs.
- > Strain gauges shall be packed carefully as per standard, with proper labelling for type, resistance, and batch number.
- > Packaging must protect against moisture and damage.
- All strain gauges and accessories (lead wires, adhesives, etc.) must be supplied in durable, protective packaging with clear labelling for ease of handling and traceability.

Important Instructions:

- > Packing and Transit Requirements: The shortlisted bidder shall ensure that all Strain gauge items are supplied with appropriate and secure packing, suitable for the nature of the materials and mode of transportation, to prevent any loss, damage, deformation, or deterioration during handling and transit.
 - Packaging must be carried out in a manner consistent with industry best practices to
 ensure that the goods are delivered to the designated ICAT location in perfect and usable
 condition.
 - Any damage or loss incurred during transit due to inadequate packing, marking, or handling shall be the sole responsibility of the supplier.



- ICAT reserves the right to **reject consignments received in damaged or substandard condition**, and the supplier shall be required to **replace such items at no additional cost**, within a timeframe specified by ICAT.
- ➤ Packing of Strain gauges: Shortlisted bidder should supply the Strain gauges with proper packing and making for transit so as to be received at the destination without any loss or damage of the gauges.
- ➤ Contract Period: The rate contract shall valid for a period of One Year (12 Months) from the date of Letter of Indent (LoI). Purchase order for the required quantities will be released on as and when required basis as per agreed rates in the LoI during the contract period.
- ➤ **Submission of Sample Sets**: After submission of the technical bid, the bidders must submit one pack of randomly informed models of each type i.e. Showa & HBK respectively within 7 to 10 working days for approval , in accordance with "*Annexure B*". The inspection will serve as a pass/fail criterion, and only successful inspection will be considered for technical evaluation.
- ➤ **Payment Terms:** 100% Payment to be released within 30 days after receipt of defect free materials at ICAT, Manesar along with valid e-way bill (Part A and Part B) & Invoice.
- > The successful bidder needs to replace the defective lot of material within 15 days from the date of intimation via email by the user dept.
- ➤ **Delivery Schedule and Penalty for Delay**: The shortlisted bidder shall ensure that all ordered materials are delivered strictly within **15 calendar days** from the date of PO.
 - If the Supplier fails to deliver the materials within the stipulated time frame, the Supplier shall be liable to pay an unconditional penalty of 0.5% (half percent) of the delayed supply value per week of delay, subject to a maximum penalty of 10% of the total value of the delayed supply.
 - The penalty shall be deducted from the payment due to the Contractor and is without prejudice to any other remedies ICAT may have under this Contract or applicable law.

- ➤ Quality Compliance and Rejection Clause: ICAT reserves the right to reject, partially or fully, any delivery that does not meet the quality standards as per the tender specifications or the approved samples submitted at the time of contract finalization.
- > The successful bidder shall designate a dedicated point of contact for ICAT and provide complete contact details of the assigned representative. This individual will be responsible for coordinating all matters related to material delivery, quality assurance, and any other operational follow-up required during the contract period.
- > Firm Pricing: The rates quoted and accepted under this Contract shall remain firm and fixed throughout the entire duration of the Annual Rate Contract. No request for price escalation, rate enhancement, or revision shall be entertained under any circumstances, including fluctuations in market conditions, raw material costs, taxes, or duties.
- ➤ Rejection of Incomplete or Conditional Bids: Bids that are incomplete, ambiguous, or conditional in nature, or that deviate in any manner from the terms and conditions specified in the tender document, shall be summarily rejected at the sole discretion of ICAT. Bidders are advised to ensure strict compliance with all tender requirements.
- > Conformity with Specifications and Approved Samples: All materials supplied under this Contract must strictly conform to the specifications stated in the respective Purchase Orders and match the samples previously approved by ICAT.
 - If the delivered materials are found to be non-compliant with either the approved specifications or samples, ICAT reserves the right to reject the entire or partial supply at its sole discretion.
 - Rejected materials shall be taken back by the supplier at their cost and risk. The supplier shall be required to replace the rejected items within a stipulated period as determined by ICAT.



- The decision of ICAT regarding conformity of the delivered materials to the required specifications and/or approved samples shall be final, binding, and conclusive, and shall not be subject to challenge or dispute.
- > Subletting of Contract: The tenderer shall not sublet, transfer or assign the tender or any thereof without written permission of the ICAT. In the event of the contractor contravening this condition, the ICAT has the right to terminate the contract.

Annexure C General Terms & Conditions

- 1. **Scope of Supply/Work:** Annual Rate Contract for Supply of Strain Gauges and accessories As and When Need Basis at ICAT Centre 1, Manesar (Haryana).
- 2. **Billing Addresses:** International Centre for Automotive Technology, Plot No. 26, Sector 3, Near HSIIDC, IMT Manesar, Guru gram 122051, GST No. 06AABAN9435G2ZI.
- **3. Delivery Address:** International Centre for Automotive Technology, Plot No. 26, Sector 3, Near HSIIDC, IMT Manesar, Gurugram 122051, GST No. 06AABAN9435G2ZI.
- 4. **Offer Validity:** Bids should remain valid for at least **180 days** from the date of opening the Technical Bid. Bids with a shorter validity period will be rejected. ICAT reserves the right to request an extension of the validity period, if required.
- 5. **Pricing and Discrepancies:** Prices must be quoted in INR and in figures only. In case of a discrepancy between the unit price and the total price calculated by multiplying the unit price and quantity, the unit price will prevail, and the total price will be corrected.
- 6. **Product Specifications & Compliance:** The bidder must quote products strictly according to the technical specifications outlined in the tender. A detailed technical compliance statement, including brand names, specifications, and supporting documents, must be submitted with the technical bid. Each page of the bid must be signed and stamped by the authorized signatory. Failure to comply with this may result in bid rejection.
- 7. **Unsatisfactory Performance:** ICAT reserves the right to assess the performance of the bidder's work and may reject any system or component that does not meet the required standards. If the performance is unsatisfactory, ICAT may reject the system, either partially or fully, and the bidder will be bound by ICAT's decision.
- 8. **Contract Termination:** If the vendor's performance is unsatisfactory regarding timely delivery or product quality, ICAT will issue a warning letter. If the issues persist after a second warning, ICAT reserves the right to terminate the contract with **30 days'** written notice without further explanation. Any amounts due to the vendor will be paid or forfeited as per the contract terms, and the vendor must withdraw their materials from ICAT premises within a month.
- 9. **Confidential Information:** Both ICAT and the selected bidder shall maintain the confidentiality of all documents, data, and information related to the contract. This information shall not be disclosed to any third party without prior written consent.
- 10. **Dispute Resolution:** Any dispute arising out of this tender shall be referred to arbitration, with the decision of the arbitrator appointed by the Director of ICAT being binding. If disputes persist, the matter will be referred to the High Court of Haryana or another appropriate court in Gurugram (Haryana).
- 11. **Amendment or Withdrawal of Tender:** ICAT reserves the right to amend or withdraw the tender at any stage without any obligation to notify the bidders. ICAT also reserves the right to disqualify any bidder at any stage, and to reject any or all bids without assigning reasons.
- 12. **Force Majeure:** Force Majeure refers to any event beyond the control of either ICAT or the bidder that prevents the fulfilment of contractual obligations. Such events include natural disasters, government actions, wars, strikes, or epidemics. In case of Force Majeure, the affected



- party shall notify the other party within **10 days** and will not be held liable for delays resulting from such causes.
- 13. Please ensure that ATC documents must be signed and stamped on all pages as a token of acceptance of all the terms and conditions.
- 14. Law of the Republic of India are applicable to this tender.
- 15. Qualification Criteria: The bidder whose bid meets the technical specification and evaluation criteria given above would only be considered (As per conditions mentioned in Evaluation Criteria).
- 16. System of Award of Contract: The bidder who satisfies the qualification criteria and offers lowest (L1) would be selected. The financial evaluation will be made based on quantity mentioned in Annexure B. The order would be awarded to the L1 bidder among the technically qualified bidders. ICAT may split the order in two parts i.e. PART A and PART B, if deemed fit.
- 17. **Relaxation in Prior Turnover and Experience**: The condition of prior turnover and prior experience may be relaxed for start-up enterprises recognized by the Department for Industry & Internal Trade (DPIIT), subject to meeting quality & technical specifications. Startups may be MSMEs or otherwise. Such relaxation can be provided in the case of procurement of works as well. It is further clarified that such relaxation is not optional but normally has to be ensured, except in case of procurement of items related to public safety, health, critical security operations and equipment, etc) where adequate justification exists for the Procuring Entity not to relax such criteria. The decision of the Procuring Entity in this regard shall be final.
- 18. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than INR 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate. In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.
- 19. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods.
