Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

5. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing service providers to include additional charges up to a specified percentage of the item-level total value, including add-ons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. Clarification on Bid Document:** Prospective Bidders requiring any clarification on the tender documents, technical specifications, scope of work, or contractual conditions may submit their queries in writing to the Purchaser within the time period specified in the tender schedule. All requests for clarifications shall clearly reference the relevant clause, section, or requirement for which the clarification is sought. Clarifications submitted after the prescribed deadline may not be considered. The Purchaser shall issue clarifications, amendments, or corrigenda, as deemed necessary, and the same shall be uploaded on the designated GeM portal/official communication channel only. No verbal clarification or information provided by any official shall be binding on the Purchaser. Bidders shall be deemed to have taken into account all clarifications and corrigenda issued prior to the submission of their bids, and failure to do so shall not constitute a valid basis for any claim, deviation, or request for extension or additional cost at any stage of the procurement or contract execution.

- 2. Site Visit:** The Bidder is advised, in its own interest, to visit and examine the site and its surroundings at the Admin Building, ICAT Centre-2, Manesar (Har yana), and to obtain all information that may be necessary for preparing a responsive and well-informed bid for the **“Supply, Installation, Testing and Commissioning of Manual Call Points (MCPs), including the Integration of Lift Exhaust Fans, Basement Ventilation Fans, and all other relevant systems with the Fire Alarm Panel,”** as specified in the Scope of Work and ATC Document. The Bidder shall be deemed to have fully satisfied itself regarding the site conditions, existing infrastructure, access constraints, working environment, and any other factors that may affect the execution of the works. Failure by the Bidder to undertake a site visit or to obtain relevant information shall not relieve the Bidder from any responsibility to perform the contractual obligations in accordance with the terms of the tender and shall not form a basis for any claim for additional cost or time. The site visit, if undertaken, shall be carried out at the Bidder’s own expense and risk, and any coordination for access shall be made with the designated ICAT authorities prior to the visit.
- 3. Deviations, and Conditional Bids:** Bids submitted with any condition, deviation, assumption, qualification, or reservation that is inconsistent with or alters the terms, specifications, or requirements of this tender, the Scope of Work, the ATC Document, or the standard GeM Contract Terms and Conditions shall be treated as conditional bids and shall be liable for rejection. The Purchaser shall not accept any bid that seeks to modify the contractual obligations, delivery timelines, technical specifications, payment terms, warranty requirements, or any other mandatory provisions stipulated in the tender documents. No conditional rebate, linkage to external factors, or request for future negotiation shall be entertained. The Bidder shall be deemed to have fully understood and unconditionally accepted all tender terms and requirements by submitting its bid. Any conditional bid, whether explicit or implied, shall be rejected without further reference to the Bidder, and the decision of the Purchaser in this regard shall be final and binding.
- 4. Product Lifecycle Assurance and Post-Supply Support Commitment:** The Bidder shall ensure comprehensive service and technical support for all equipment supplied under this tender for a minimum period of **five (5) years** from the date of final acceptance. All products offered shall be current, supported models and shall not be classified as **“end-of-life”** or **“end-of-sale”** as of the date of final acceptance. In the event that the manufacturer discontinues, withdraws, or otherwise ceases support for any quoted product prior to delivery, the Supplier shall, at no additional cost to the Purchaser, provide a replacement product of equal or superior quality, specifications, and functionality. Any such replacement shall be subject to the Purchaser’s prior approval and shall ensure seamless continuity of operations without disruption to the project requirements.
- 5. Delivery, Installation, and Commissioning Timeline:** The Supplier/Contractor shall ensure that the delivery, installation, and commissioning of the equipment is completed within the timeline specified in the tender documents.

actor shall complete the entire scope of work under this tender for the **“Supply, Installation, Testing and Commissioning of Manual Call Points (MCPs), including the Integration of Lift Exhaust Fans, Basement Ventilation Fans, and all other relevant systems with the Fire Alarm Panel, as specified in the Scope of Work and ATC Document for the Admin Building at ICAT Centre-2, Manesar (Haryana),”** within **one hundred and twenty (120) days from the date of award of the GeM Contract**. This period shall include all activities related to supply, installation, integration, testing, commissioning, documentation, and obtaining necessary approvals. Any delay beyond the stipulated completion period shall attract the applicable actions, penalties, and remedies as per the GeM Contract Terms and Conditions and the ATC Document.

- 6. Warranty Condition:** The Supplier shall provide a comprehensive warranty for all goods, equipment, and systems supplied, installed, and commissioned under this Contract for a period of **twelve (12) months from the date of final acceptance by ICAT**. During the warranty period, the Supplier shall, at its own cost, promptly repair, replace, or rectify any defects, malfunctions, or failures arising out of design, material, workmanship, or installation, ensuring that the equipment and systems perform in accordance with the specifications and intended purpose. All warranty services, including replacement of parts and rectification of defects, shall be carried out in a timely manner without causing disruption to ICAT’s operations. The warranty obligations shall be in addition to, and not in lieu of, any other remedies or guarantees provided under the contract or applicable law. The Supplier shall be fully responsible for all costs associated with transportation, labour, and materials required for warranty maintenance.
- 7. Payment Terms:** ICAT shall release **100% of the contract value within 30 (thirty) days from the date of receipt of a valid final invoice and upon satisfactory verification and formal written acceptance by ICAT**. The Supplier shall be responsible for ensuring that all contractual obligations, including documentation, rectification of defects, and compliance with specifications, are fulfilled prior to submission of the final invoice. Any liquidated damages, penalties, or recoveries due under the Contract may be deducted from the payment. The Contract price is firm and fixed, and no escalation shall be payable except as expressly provided in the Contract.
- 8. Liquidated Damages (LD) Condition:** In the event of any delay in the delivery, installation, testing, commissioning, or integration of the systems beyond the stipulated completion timelines, and where such delay is not attributable to ICAT, the Supplier shall be liable to pay Liquidated Damages (LD) to ICAT. **The LD shall be levied at the rate of 0.5% (half percent) of the total contract value per week or part thereof of delay, subject to a maximum ceiling of 10% (ten percent) of the total contract value.** The levy of Liquidated Damages shall be without prejudice to ICAT’s right to terminate the contract or pursue any other remedies available under the contract or applicable law. The Supplier acknowledges and agrees that the LD is a genuine pre-estimate of the loss likely to be suffered by ICAT due to delay and is not intended as a penalty.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The

Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
