Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the

original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

SHED (Variable Volume/ Variable Temperature) System Upgradation for Vehicle Test Lab

The supplier shall have total responsibility for the process including all phases of design, manufacture, assembly and functional testing of the equipment prior to shipment, installation, system checking and functional testing after installation for all its capabilities. The Bidder is requested to submit the detailed specifications of the proposed equipment. Please note that “No” deviation is allowed.

The Bidder is also requested to submit technical documentation, Acceptance Test Reports all the equipment required in this tender. The Test Reports shall be based on previous projects the Bidder was involved in and shall include the contact details of the corresponding customer. Additionally, to this, the Bidder is also requested to include calibration reports of previously supplied and installed facilities for each and all the equipment required in this tender. Existing SHED evaporative emission system for the Vehicle Test Lab is supplied by M/s Webber EMI Inc. The responsibility of integrating for the equipment required in this tender lies with the Successful Bidder. The bidder shall discuss their requirements with respect to SHED evaporative emission system with M/s Webber EMI Inc. directly. Please note, ICAT will not be part of any discussion or will not be responsible for any integration issues and the sole responsibility of integration of SHED system with the existing set-up lies with the successful bidder itself. The expected performances of the cells, including the requirements on the Integration, are listed under Acceptance Criteria, and the Bidder is responsible for achieving the mentioned performances.

Additional Terms & Conditions (ATC)

The Bidder shall be required to work out details of interfaces with the Existing SHED system and submit the detailed project stating all requirements at the time of bid submission.

Connections With Reference Gas Piping.

The system offered under this tender should work with existing Ref gas piping and available Ref gas pressure. The successful bidder has to do the necessary modifications, if any modification is required. The connection for the gases from the existing gas regulators should be done by the successful bidder

Software

ICAT requires system upgrade with the latest software version free of cost (even if new software requires latest platform) within a period of five years after commissioning, if any. The referred system upgradation shall be applicable in the event of:

The work is to be completed within stipulated time from the date of award of contract by way of Letter of Acceptance, as mentioned in the milestones appearing above.

Bidder is required to submit a detailed timing plan that shall include all phases of design, manufacture, installation and commissioning for ICAT.

The Bidder is also required to deliver, together with its Offer, a detailed implementation layout indicating the placement of their equipment along with the existing set-up in the emission room. This layout shall be according to the existing lab Layout.

The Bidder for this tender is responsible for integration of the equipment's required in this tender with the existing Evaporative emission system for Vehicle Test Lab which has been supplied by M/s Webber EMI Inc. Please Note, ICAT will not be part of any discussion or will not be responsible for any integration issues and the sole responsibility of integration of the Emission system lies with the bidder itself.

Exclusions

ICAT will provide electrical supply (via local isolators), water, calibration gases, fuels and compressed air to enable the equipment commissioning. It will be the responsibility of the equipment supplier to make all the connections from these service points to the equipment.

Service Support

The Bidder is required to have a service support set up in India with sufficient trained manpower. The Bidder shall commit a maximum response time of 24 hours, which means that in case of any breakdown within 24 hours, the Bidder's personnel should reach the site, assess the cause of the breakdown, take necessary action to resolve the issue and submit the corrective actions schedule.

Warranty

The Bidder shall be required to provide a comprehensive warranty of two years from date of final acceptance, for equipment supplied under this tender, including the following:

The existing SHED Evaporative emission system for SHED Lab has been supplied by M/s Webber EMI Inc. The integration under this upgradation of SHED system will be under the scope of successful bidder.

The supplier has to guaranty that the following emissions regulations can be performed with the SHED evaporative emission system:

The analytical system must be able to test both Euro 3 to Euro 6E , BS-III to BS-VI Gasoline and Flex fuel vehicles.

The system shall also include an automation system that allows the system to provide a fully automated test procedure on the SHED system including all the devices involved like: Hydrocarbon Analyser, Evaporative emission measurement enclosure, Temperature recording system, Pressure recording system, Fans, weather station and additional I/O signals including connection to the vehicle. In addition to the above, the automation system shall be upgradeable with other devices which might be required for development activities, and the successful bidder shall declare the same in the technical bid.

It has to include the following major equipment's:

- Hydrocarbon analyser.
- Integration of existing evaporative emission measurement enclosure, weather station and fans.
- Automation & data acquisition system.
- Temperature and Pressure recording system
- Integration of existing Calibration gases and gas handling system.

A.3. TECHNICAL SPECIFICATIONS

3.1 Analytical System

3.1.1 Hydrocarbon analyser

The analytical system has to be able to perform the tests as per Regulation Euro 3 to Euro 6, BS-III to BS-VI Gasoline vehicles along with the regulations/cycles covered under clause 2.1.

The analyser shall be installed in such way that the access shall be possible from the front with plug & play technology. Additionally, the system supplied should have the latest operating system.

The following gas component have to be measured:

Additional Terms & Conditions (ATC)

- Components with a limit according to the main emissions regulations:
 - total hydrocarbons (THC)

All components in contact to reactive sample gas shall be made of stainless steel or Teflon.

The system shall be operated by two different modes:

- **Manual operation:** In this case the system shall be controllable over a touch screen installed in the front of the cabinet. Easy navigation through the system shall be required.
- **External operation:** In this case the analyser shall be controllable (via Automation system) over host interface via RS232 or LAN interface using the AK protocol or any other latest/open protocol.

System should meet EMI/EMC compatibility Machinery & safety standards as per the current International Standards. The successful bidder shall provide certificate along with the technical bid.

3.1.2 Analyser for Emission Analysis:

The analyser shall have below ranges for measuring emission and modal traces.

Supplier should indicate the actual ranges available in the analyser if there are different to the tables above. The analysers shall incorporate a minimum of 2 measuring ranges freely selectable.

3.1.3 Analyser special functions

The analyser shall have at least the following special functions:

- Gas divider
- Real time Trend chart
- Automatic calibration
- Span Gas Selector
- Manual measurement logging option in excel format

Additional Terms & Conditions (ATC)

3.1.4 Hydrocarbon analyser data recording system

The hydrocarbon analyser has to be fitted with a device to record electrical signal output either by via itrend or other data processing system at a frequency of at least once per minute. The recording system must have operating characteristics at least equivalent to the signal being recorded and shall provide a permanent record of results.

3.2 Evaporative emission measurement enclosure

After upgradation of existing chamber, the evaporative emission measurement enclosure has to be a gas-tight rectangular measuring chamber able to contain the vehicle under test. The inner surface of the enclosure shall be impermeable and non-reactive to hydrocarbons. The temperature conditioning system to be capable of controlling the internal enclosure air temperature and an average tolerance of 1 °C over the duration of the test or should follow the regulation test cycle.

The control system to be tuned to provide a smooth temperature pattern that has a minimum of overshoot, hunting, and instability about the desired long term ambient temperature profile. Interior surface temperatures shall not be less than 5 °C nor more than 55 °C at any time during the diurnal emission test.

Interior surface temperatures of wall shall not be below 20 °C, nor above 52 °C for the duration of the hot soak rest.

3.2.1 Variable volume enclosure

The existing variable-volume enclosure expands and contracts in response to the temperature change of the air mass in the enclosure. Means of accommodating the internal volume changes are movable panel(s), in response to internal pressure changes by exchanging air from outside the enclosure.

Any method of volume accommodation must limit the differential between the enclosure internal pressure and the barometric pressure to a maximum value of ± 0.5 kPa.

The enclosure has to be capable of latching to a fixed volume. A variable volume enclosure to be capable of accommodating a +7 per cent change from its nominal volume considering temperature and barometric pressure variation during testing.

3.2.2 SHED control cabinets

SHED control cabinet is the electrical unit and control all electrical equipment to operate the system i.e.,

- I/O signal acquisition
- Interfaces
- Safety

3.2.3 SHED SMC

SHED sensor management console to perform the fully automated sensor calibrations and adjustments. It should contains the following functions

- User Interface
- Perform the calibration of one or multiple sensors at a time

- Data storage
- Validity of calibration and references
- Reference management and scheduling of required calibration
- Polynomial calculation and automatic polynomial interface
- Reports

3.3 Temperature recording system

The temperature in the chamber has to be recorded at two points by temperature sensors which are connected so as to show a mean value. The measuring points to be extended approximately 0.1 m into the enclosure from the vertical centre line of each side wall at a height of 0.9 ± 0.2 m.

Temperatures throughout the measurements, to be recorded into a data processing system at a frequency of at least once per minute.

The successful bidder should ensure the accuracy of the temperature recording system.

The recording or data processing system to be capable of resolving time to ± 15 seconds.

3.4 Pressure recording system

The difference Δp between barometric pressure within the test area and the enclosure internal pressure throughout the measurements, has to be recorded into a data processing system at a frequency of at least once per minute

The accuracy of the pressure recording system to be within ± 0.3 kPa and the pressure shall be capable of being resolved to ± 0.025 kPa

The recording or data processing system shall be capable of resolving time to ± 15 seconds.

3.5 Existing Fans

The existing chamber to have one or more existing fans or blowers of like capacity 0.1 to 0.5 m³/sec. with which to thoroughly mix the atmosphere in the enclosure and it should be possible to attain an even temperature and hydrocarbon concentration in the chamber during measurements. The vehicle in the enclosure should not be subjected to a direct stream of air from the fans or blowers.

Additional Terms & Conditions (ATC)

For the analyser controller specific service/maintenance/calibration features shall be included:

3.6 Automation and data acquisition system

3.6.1 System description.

The automation system shall allow the users to perform evaporative emissions testing, quality control operations on hardware and calibration.

It coordinates the use of the systems of hardware required for evaporative emission testing such as the new Gas Analyser System, the existing evaporative emission enclosure, the temperature recording system, the pressure recording systems, the fans, printers, weather stations and any other additional equipment. The system has to be upgradeable to incorporate in future new devices.

The automation system should have the following components:

- Process computer with database and user interface;
- Process I/O terminal
- Interfaces
- Data evaluation and analysis

3.6.2 Technical specification

The automation system should provide a modular software concept with user friendly architecture. The modular software structure guarantees a flexible system for instance for onsite configuration and parameterization which can be also done by the customer.

The automation system shall include all necessary reports and calculations for certification testing and modal gas measurement as well. Provision for reports and calculations for raw gas measurement has to be taken into account. A reporting tool allows the customer to generate own test reports and layouts but also modify the calculations according to the latest regulations.

Additional Terms & Conditions (ATC)

The entire configuration data, test data and report data as well shall be stored into database interfacing by ASAM-ODS.

The system has to support all standard communication protocols like ASAM-AK or ASAM-GDI but also other common interface protocols RS232C, LAN / Ethernet, CAN, MCD, Analog Input or Discrete I/O to coordinate the use of the systems of hardware required for evaporative emission testing such as the Gas Analyser System, the evaporative emission enclosure, the temperature recording system, the pressure recording systems, the fans, printers, weather stations. If the bidder wants to use the existing system, he shall check the functionality as well as the workability of the existing system.

A.5. Calibration certificates

Calibration certified traceable to international standards for the complete emission analysis system shall be supplied. All test major equipment shall meet the calibration requirements of GTR 15 Annex 5 or better.

A.6. Acceptance Test

6.1 Approval of project

All drawings, interfaces with Existing Set-up and list of elements to be supplied, including main specifications, shall be verified and accepted by ICAT. Modifications shall be implemented on those documents by the supplier, should ICAT require to.

6.2 Acceptance for Emission system SHED lab

6.2.1 Full system check

23. Any Dispute/Difference arising out of or relating to this tender: In case any dispute arises between ICAT and the other party due to any term or matter, both the parties will opt to resolve it through mutual understanding and discussion. In case, dispute remains even after discussions, then it shall be binding upon parties to resolve issues under the provisions of Arbitration & Conciliation Act, 1996 as amended from time to time. Under this provision, Director, ICAT with the concurrence of both the parties shall appoint Sole Arbitrator to resolve the issue and both the parties will have to abide by the decision. 24. The tender document is not an offer and is issued with no commitment. ICAT reserves the right to withdraw this notice inviting tender or vary any part thereof at any stage. ICAT further reserves the right to disqualify any bidder, should it be so necessary at any stage. ICAT reserves the right to reject any or all the tenders, wholly or partly, without assigning any reason thereof and shall not be bound to accept the lowest tender.
25. Law of the Republic of India are applicable to this tender.
