If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
3. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
4. If the bidder is a DPIIT registered Startup, the bidder shall be relaxed from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover shall upload the supporting documents to prove his eligibility for Relaxation.
5. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
6. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within $L-1+ 15\%$ (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public

Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- If number of technically qualified bidders are only 2 or 3.
- If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

1. **Clarification on Bid Document:** Prospective Bidders requiring any clarification on the tender documents, technical specifications, scope of work, or contractual conditions may submit their queries in writing to the Purchaser within the time period specified in the tender schedule. All requests for clarification shall clearly reference the relevant clause, section, or requirement for which the clarification is sought. Clarifications submitted after the prescribed deadline may not be considered. The Purchaser shall issue clarifications, amendments, or corrigenda, as deemed necessary, and the same shall be uploaded on the designated GeM portal/official communication channel only. No verbal clarification or information provided by any official shall be binding on the Purchaser. Bidders shall be deemed to have taken into account all clarifications and corrigenda issued prior to the submission of their bids, and failure to do so shall not constitute a valid basis for any claim, deviation, or request for extension or additional cost at any stage of the procurement or contract execution.

2. **Site Visit:** The Bidder is advised, in its own interest, to visit and examine the site at ICAT Centre-II, Manesar (Haryana), before submitting the bid for the **Procurement of Conventional Flooded and SMF Type Lead-Acid Batteries**. The visit is intended to enable the Bidder to understand the **application of these batteries**, verify the existing battery configuration, accessibility, dimensions, terminal arrangement, and any other site-specific requirements relevant to the intended application.
The Bidder shall be deemed to have fully satisfied itself regarding the site conditions and all factors that may affect the supply of the batteries for their intended application. No claim for additional cost, extension of time, or any other compensation arising out of the Bidder's failure to inspect the site or obtain relevant information shall be entertained by ICAT.
The site visit, if undertaken, shall be at the Bidder's own cost and risk. Prior coordination with the designated ICAT authority shall be made with the designated ICAT authority before the visit.
3. **Deviations, and Conditional Bids:** Bids submitted with any condition, deviation, assumption, qualification, or reservation that is inconsistent with or alters the terms, specifications, or requirements of this tender, the Scope of Work, the ATC Document, or the standard GeM Contract Terms and Conditions shall be treated as conditional bids and shall be liable for rejection. The Purchaser shall not accept any bid that seeks to modify the

contractual obligations, delivery timelines, technical specifications, payment terms, warranty requirements, or any other mandatory provisions stipulated in the tender documents. No conditional rebate, linkage to external factors, or request for future negotiation shall be entertained. The Bidder shall be deemed to have fully understood and unconditionally accepted all tender terms and requirements by submitting its bid. Any conditional bid, whether explicit or implied, shall be rejected without further reference to the Bidder, and the decision of the Purchaser in this regard shall be final and binding.

4. **Product Lifecycle Assurance and Post-Supply Support Commitment:** The Bidder shall supply only new, unused, and factory-fresh Conventional Flooded and SMF Type Lead-Acid Batteries manufactured by the Original Equipment Manufacturer (OEM) or its authorized manufacturer. The batteries shall be from the OEM's current production range and shall conform to the technical specifications prescribed in the tender.

The batteries supplied shall not be obsolete, refurbished, repaired, reconditioned, or manufactured from discontinued production batches. The date of manufacture of each battery shall not be older than six (03) months from the date of supply, unless otherwise specified in the tender.

The successful Bidder shall provide the applicable OEM warranty for all supplied batteries. During the warranty period, any battery found defective due to manufacturing defects or premature failure under normal operating conditions shall be repaired or replaced with a new battery of equivalent or higher specifications at no additional cost to ICAT.

In the event that the quoted battery model is discontinued by the OEM before completion of the supply, the Bidder shall, with the prior approval of ICAT, supply an equivalent or higher specification battery of the same or a better OEM make at no additional cost, without affecting the delivery schedule or any other contractual obligations.

5. **Delivery, Installation, and Commissioning Timeline:** The Supplier shall complete the entire scope of supply under this tender for the "Procurement of Conventional Flooded and SMF Type Lead-Acid Batteries at ICAT Centre-II, Manesar (Haryana)," as specified in the Scope of Work and ATC Document, within 45 (Forty-Five) days from the date of award of the GeM Contract. This period shall include all activities related to manufacturing, inspection (where applicable), packing, forwarding, transportation, insurance, loading, unloading, delivery of the batteries, submission of warranty documents, and all other documents required under the Scope of Work and ATC Document. Any delay beyond the stipulated delivery period shall attract the applicable actions, penalties, and remedies as per the GeM Contract Terms and Conditions and the ATC Document.

6. **Warranty Condition:** The Supplier shall provide a **minimum comprehensive warranty of 24 (Twenty-Four) months** from the date of delivery and acceptance by ICAT for all **Conventional Flooded and SMF Type Lead-Acid Batteries** supplied under this Contract. During the warranty period, the Supplier shall, at its own cost, promptly replace any battery that fails due to manufacturing defects, defective material, poor workmanship, or premature failure under normal operating conditions. The replacement battery shall be new, unused,

and of the same or higher specifications and shall be supplied without any additional cost to ICAT.

The Supplier shall be responsible for all costs associated with warranty services, including transportation, loading, unloading, labour, and replacement of defective batteries. The warranty obligations shall be in addition to, and not in substitution of, any other rights and remedies available to ICAT under the GeM Contract, the Additional Terms & Conditions (ATC), and applicable laws.

(i) Replacement under Warranty: Any replacement under the warranty provisions shall be carried out by the supplier at no additional cost to the purchaser, including all charges for freight, insurance, and any other expenses associated with the replacement at the site.

(ii) Defective Goods and Supplier's Obligation: Should it be necessary for the supplier to replace or renew any defective goods under this clause, the replacement shall be carried out within 15 working days

7. **Payment Terms:** ICAT shall release *100% of the contract value within 30 (thirty) days from the date of receipt of a valid final invoice and upon satisfactory verification and formal written acceptance by ICAT.* The Supplier shall be responsible for ensuring that all contractual obligations, including documentation, rectification of defects, and compliance with specifications, are fulfilled prior to submission of the final invoice. Any liquidated damages, penalties, or recoveries due under the Contract may be deducted from the payment. The Contract price is firm and fixed, and no escalation shall be payable except as expressly provided in the Contract.
8. **Liquidated Damages (LD) Condition:** In the event of any delay in the delivery, installation, testing, commissioning, or integration of the systems beyond the stipulated completion timelines, and where such delay is not attributable to ICAT, the Supplier shall be liable to pay Liquidated Damages (LD) to ICAT. *The LD shall be levied at the rate of 0.5% (half percent) of the total contract value per week or part thereof of delay, subject to a maximum ceiling of 10% (ten percent) of the total contract value.* The levy of Liquidated Damages shall be without prejudice to ICAT's right to terminate the contract or pursue any other remedies available under the contract or applicable law. The Supplier acknowledges and agrees that the LD is a genuine pre-estimate of the loss likely to be suffered by ICAT due to delay and is not intended as a penalty.
9. **Delivery and Insurance Condition:** The Supplier shall be solely responsible for the safe, secure, and timely delivery of all goods, equipment, and materials under this Contract to the designated delivery location specified by ICAT. Delivery shall be made strictly in accordance with the delivery schedule and milestones stipulated in the Contract. All items shall be properly and securely packed, handled, and transported in a manner that ensures full protection against damage, corrosion, pilferage, or deterioration during transit and storage. The Supplier shall be fully liable for any loss, damage, or deterioration occurring prior to the formal receipt and acceptance of the goods by ICAT.

The Supplier shall, at its own cost, arrange comprehensive transit insurance covering the full value of the goods against all risks from the point of dispatch to the point of final delivery at ICAT's site. Such insurance shall be obtained from a reputable insurer and shall remain valid until the goods are successfully delivered, inspected, and formally accepted in writing by ICAT.

The offloading and unloading of all materials at the project site shall be the sole responsibility of the Supplier and shall be performed in a safe, careful, and timely manner, using suitable equipment and manpower. ICAT shall not be responsible for providing assistance or bearing any costs related to the offloading or handling of materials at the site.

Any shortage, damage, loss, or deterioration observed at the time of delivery shall be promptly rectified or replaced by the Supplier at no additional cost to ICAT, without affecting the delivery schedule. The risk and responsibility for the goods shall remain with the Supplier until the materials are delivered, offloaded, inspected, and formally accepted in writing by ICAT.

- 10. Unsatisfactory Performance:** The bidder herein agree that ICAT shall have sole and discretionary right to assess the performance(s) of the Bidder equipment(s), either primary and or final, and ICAT, without any liability whatsoever, wither direct or indirect, may reject the system(s) / equipment(s) provided by the Bidder, in part or in its entirety, without any explanation to the Bidder, either during the pre and or post-test period should the same be unsatisfactory and not to the acceptance of ICAT. The Bidder covenants to be bound by the decision of ICAT without any demur in such an eventuality.

11. Assignment and Sub-Contracting

- The Successful Bidder shall not, without the prior written consent of the Procuring Entity, sublet, assign, transfer, delegate, or otherwise dispose of the Contract or any part thereof, or any rights, interests, benefits, or obligations arising therefrom, in any manner whatsoever.
- The Successful Bidder shall provide the Procuring Entity with prompt written notification of all subcontracts awarded under this Contract that were not disclosed in the original bid or contract documentation. Such notification shall not relieve or discharge the Successful Bidder from any liability, obligation, or responsibility under this Contract.
- Subcontracting shall be permitted solely for the procurement of bought-out items and incidental works or services directly related to the execution of the Contract. All subcontracted work shall be subject to the Successful Bidder's full responsibility and compliance with the terms, conditions, and obligations of this Contract. Subcontracting shall not be used as a means to circumvent or diminish the Successful Bidder's contractual responsibilities or performance obligations.
- Any assignment, subletting, or transfer of the Contract, or any part thereof, without the prior written approval of the Procuring Entity, shall be deemed a material breach of Contract. In the event of such unauthorized assignment or subcontracting, the Procuring Entity reserves the right to invoke any or all remedies available under the Contract and/or applicable law, including but not limited to termination of the Contract, forfeiture of performance guarantees, and claims for damages.

12. ICAT's Rights

- **Right to Inspect and Verify:** The International Centre for Automotive Technology (ICAT) reserves the right to inspect, test, and verify the *equipment* and all related components at any stage during manufacturing, pre-delivery, installation, commissioning, and operational phases to ensure strict compliance with the tender specifications, contractual terms, and applicable standards.
 - **Right to Reject:** ICAT shall have the right to reject any equipment, parts, or services that do not conform to the prescribed technical specifications, quality requirements, or contractual obligations without prejudice to its rights under the contract. Rejected goods or services shall be replaced or rectified by the Successful Bidder at no additional cost to ICAT within the stipulated time frame.
 - **Right to Seek Clarifications and Modifications:** ICAT reserves the right to seek clarifications, request additional information, or require modifications to the equipment or services at any point during the contract period to ensure alignment with its operational requirements and safety standards.
 - **Right to Audit and Access Records:** ICAT shall have the right to audit, access, and review all relevant documentation, quality records, test reports, and certifications related to the *equipment* supplied under this contract.
 - **Right to Enforce Contractual Remedies:** In the event of breach, delay, or non-performance by the Successful Bidder, ICAT reserves the right to invoke any and all remedies available under the contract, including but not limited to penalties, liquidated damages, withholding of payments, or termination of the contract.
 - **Right to Final Acceptance:** The final acceptance shall rest solely with ICAT and shall be contingent upon satisfactory fulfilment of all technical, operational, and contractual requirements as determined by ICAT's authorized representatives.
 - **Right to Reject, Modify, or Cancel Tender:** ICAT expressly reserves the right to reject, modify, or cancel the tender process, in whole or in part, at any stage without assigning any reason thereof and without incurring any liability whatsoever to any bidder or party.

 15. **Offer Validity:** Offers should be valid for a minimum of **One Hundred Eighty (180) Days** from the date of opening the Technical Bid. A bid, valid for a shorter period, is liable to be rejected. ICAT and Manesar may ask the bidders to extend the period of validity, if required.
 16. **Price:** The prices are to be quoted in INR in figures only. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected.
 17. Please ensure that **ATC documents** must be signed and stamped on all pages as a token of acceptance of all the terms and conditions.
 18. **Termination of Contract:** If the performance of the successful bidder (hereinafter referred to as the "Vendor") is found to be unsatisfactory — whether in terms of timely delivery, quality of the goods supplied, or non-compliance with the contractual obligations — ICAT shall issue a written notice to the Vendor, treating the same as a formal warning.

If, notwithstanding the first warning, the Vendor fails to rectify the deficiencies or does not take corrective measures within **fifteen (15) days** from the date of the first notice, a **second and final warning** shall be issued.

Should the Vendor continue to remain non-compliant or fail to meet the required performance standards even after issuance of the second warning, **ICAT reserves the right to terminate the contract/work order**, in whole or in part, **by giving one (1) month's written notice**, without assigning any further reason and without any liability whatsoever on the part of ICAT.

Upon termination:

- The contract shall become **null and void** from the date of expiry of the notice period.
- Any pending payment deemed payable to the Vendor, if any, shall be **withheld or forfeited** at the discretion of ICAT.
- **No further claims, liabilities, or compensations** of any kind shall be entertained by ICAT.
- The Vendor shall be required to **withdraw all deployed personnel, equipment, and material** from ICAT premises within **thirty (30) days** from the termination date.
- **Failure to vacate the premises** may lead to ICAT taking appropriate legal and administrative measures.

The **decision of the Competent Authority of ICAT** regarding the performance of the Vendor and termination of the contract shall be **final and binding**.

19. Confidential Information: ICAT and Selected Bidder shall keep confidential and not, without the written consent of the other party hereto, divulge to any third party any documents, data, or other information furnished directly or indirectly by the other party hereto in connection with the Contract, whether such information has been furnished prior to, during or following completion or termination of contract.

20. Dispute Resolution (Arbitration): In the event of any dispute or difference arising between the International Centre for Automotive Technology (ICAT) and the Contractor/Supplier in connection with or arising out of this Contract, including any matter relating to the interpretation or performance of its terms, the parties shall endeavor to resolve such disputes amicably through mutual discussion and consultation.

If the dispute remains unresolved **after thirty (30) days** of such mutual discussions, the matter shall, subject to the provisions herein, be referred to arbitration in accordance with the Arbitration and Conciliation Act, 1996, and any amendments thereto.

Subject to the guidelines issued by the *Department of Expenditure, Ministry of Finance, vide OM No. F.1/2/2024-PPD dated 03.06.2024*, arbitration shall be an available method of dispute resolution only where the value of the dispute is less than **₹10 crores (Rupees Ten Crore)**. This threshold refers to the value of the dispute and not the overall value of the contract. For disputes where the value exceeds **₹10 crores**, the parties shall resolve the matter through appropriate judicial forums and arbitration shall not be applicable. Where arbitration is permissible, a Sole Arbitrator shall be appointed by the Director (ICAT), with the mutual concurrence of both parties. The decision of the Sole Arbitrator shall be final and binding on both parties.

The arbitration proceedings shall be conducted in the English language, and the venue of arbitration shall be Gurugram, Haryana. The parties agree that they shall not approach any

court of law for the resolution of disputes unless the arbitration mechanism provided herein is exhausted, where applicable.

Subject to the above, the courts at Gurugram, Haryana, shall have exclusive jurisdiction over all matters arising under this contract.

21. The tender document is not an offer and is issued with no commitment. ICAT reserves the right to withdraw this notice inviting tender or vary any part thereof at any stage. ICAT further reserves the right to disqualify any bidder, should it be so necessary at any stage. ICAT reserves the right to reject any or all the tenders, wholly or partly, without assigning any reason thereof and shall not be bound to accept the lowest tender.
22. **Qualification Criteria:** The bidder whose bid meets the technical specification and evaluation criteria given above would only be considered (As per conditions mentioned in Evaluation Criteria).
23. **System of Award of Contract:** The bidder who satisfies the qualification criteria and offers lowest (L1) would be selected.
24. Law of the Republic of India are applicable to this tender.
25. **Force Majeure:** For the purpose of this Contract, "*Force Majeure*" shall mean any event or circumstance beyond the reasonable control of either party (the Successful Bidder or ICAT) which was not reasonably foreseeable, or which, with the exercise of due diligence, could not have been foreseen or prevented, and which materially and adversely affects the performance of obligations under this Contract.

Events qualifying as Force Majeure shall include, but not be limited to, the following:

- Natural calamities such as floods, droughts, earthquakes, hurricanes, cyclones, lightning, or other acts of God.
- Pandemics or epidemics, or any public health emergency declared by competent authorities.
- Acts of war (declared or undeclared), hostilities, invasion, armed conflict, terrorism, civil unrest, riots, or sabotage.
- Acts or orders of Government authorities, including but not limited to quarantine restrictions, embargoes, prohibitions, or trade restrictions imposed by any competent government authority.
- Freight embargoes, restrictions on transportation, or any unforeseen change in law or government policy materially impacting contract performance.

Obligations during Force Majeure: The party affected by a Force Majeure event shall, within **ten (10) calendar days** of the occurrence of such event, **notify the other party in writing**, providing sufficient details and evidence of the Force Majeure circumstances and its anticipated impact on the performance of contractual obligations.

Neither party shall be held liable for any **delay or failure** in the performance of its contractual obligations arising directly from such Force Majeure event, provided that:

- The obligations affected are directly related to the Force Majeure event.
- The affected party takes all reasonable steps to mitigate the effect of the Force Majeure on the performance of the contract.
- The performance is resumed as soon as reasonably practicable after the Force Majeure event ceases.

If the period of delay due to Force Majeure extends beyond **sixty (60) days**, either party shall have the right to **terminate the contract** by giving **fifteen (15) days' written notice**, without any financial repercussion or liability on either side, subject to settlement of dues already accrued prior to such termination.

The decision of ICAT regarding the existence, duration, and impact of Force Majeure shall be **final and binding** on the successful bidder.

26. Fraud and Corruption: The bidders, suppliers and contractors shall observe the highest standard of ethics during bidding and during performance of the contract. For the purposes of this provision, the following acts shall be considered as corrupt and/or fraudulent practices.

- **"Corrupt Practice"** means offering, giving, receiving, or soliciting directly or indirectly, of anything of value to influence the action of an official in the procurement process or in contract execution.
- **"Fraudulent Practice"** means misrepresentation or omission of facts in order to execution of contract.
- **"Collusive Practice"** means a scheme or arrangement between two or more bidders, with or without the knowledge of the purchaser, designed to establish bid prices at artificial, non-competitive level.
- **"Coercive Practice"** means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in a procurement process or in execution of a contract.
- During the process of evaluation of a bid or proposal for award of a contract, if it is detected that a bidder directly or through agent has engaged in corrupt, fraudulent, collusive or coercive practice in competing for the contract in question, then a) the bid shall be rejected and b) declare the firm ineligible for a specific period or indefinitely to participate in a bidding process.
- Bidders may note that GeM is capturing and showing the IP addresses used by the Buyer and Bidder(s)/Seller(s). Bids submitted from IP addresses that are identical to or shared with other Bidders/Sellers shall be deemed invalid and automatically disqualified from further evaluation.

27. Collusive Bidding or Bid Rigging or Cartelization: The Bidder(s) acknowledges and agrees that any form of bid rigging, cartelization, or coordination among bidders, aimed at manipulating the bidding process or prices, is strictly prohibited. In the event of any evidence or suspicion of collusion, bid rigging, or cartel behavior, the Tendering Authority reserves the right to reject the bid(s) and take appropriate legal action, including but not limited to debarment from future tenders and reporting to relevant authorities. Bidders are required to submit their bids independently, without any undue influence or agreement with other participants in the tender process.

28. Integrity Clause

- **Integrity Pact:** The Bidder/Supplier/Contractor shall maintain the highest standards of integrity and shall not indulge in any corrupt, fraudulent, collusive, coercive, or undesirable practices while participating in the tender process or in execution of the contract.

- **Prohibition of Corrupt Practices:** The Bidder shall not offer, give, solicit or accept, directly or indirectly, any bribe, gift, consideration, reward, commission, or other advantage as an inducement or reward for doing or forbearing to do any act in relation to the tender or contract.
- **Compliance with Laws:** The Bidder shall comply with all applicable laws, rules, regulations, and guidelines, including but not limited to the General Financial Rules (GFR) issued by the Government of India and relevant procurement manuals.
- **Declaration of Non-Conflict:** The Bidder affirms that it has not been convicted of any offense involving corrupt or fraudulent practices and is not involved in any ongoing investigation related to such offenses.
- **Consequences of Breach:** Any violation of this Integrity Clause shall entitle the Purchaser/Contracting Authority to reject the bid, terminate the contract, and take any other legal action including blacklisting/debarment as per applicable rules.
- **Reporting Mechanism:** Bidders may report any observed or suspected violation of this clause through appropriate channels as prescribed in the tender documents or procurement manuals.

29. MSE's & Startups Exemption Applicability: ICAT reserves right to relax the condition of prior turnover and prior experience for Micro or Small Enterprise (MSE) and Start-up enterprises subject to meeting of quality & technical specifications. The decision of the Procuring Entity in this regard shall be final.

- If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder may be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria shall upload the supporting documents to prove his eligibility for exemption.
- If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder may be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications.
